**ORDER:**

This order of mine will dispose an application under Sec. 439 of Criminal Procedure Code moved by accused/applicant aforesaid for his release on bail during pendency of trial.

2. Learned counsel for applicant/accused has argued that accused has been falsely implicated in this case. It is further contended that accused is in custody since 4.5.2019, he is not required for purpose of investigation and prayed that bail application my kindly be allowed.

3. On the other hand, learned Additional Public Prosecutor for State has contended that allegations against accused/applicant are serious in nature and concession of bail application cannot be extended to him.

4. I have given careful consideration to these contentions and have perused record.

5. Present case was registered against accused on statement of Pargada Noka Raju son of Pargada Vinku Naidu stating therein that he is posted as Subedar at C/O 56 APO. On 4.5.2019 he was checking documents of different candidates called for recruitment in Army. During checking, it was suspected that candidates, namely, Rambir Singh and Ram Bharat Singh were not matching with photographs affixed on their acknowledgment cards. On enquiry, person appearing on behalf of Rambir Singh has disclosed his name as Rajesh son of Maharaj Singh and person appearing on behalf of Ram Bharat Singh has disclosed his name as Sunil son of Prem Singh. In this way, accused had committed cheating with Army department in connivance with each other.

6. Obviously, allegations against accused/applicant are serious in nature. He has tried to dupe government at the time of recruitment of Army officials and it is a serious matter, because defence of nation has been put in stake as his real intention cannot be known. As such, application in hand is dismissed.

Police record be returned.

File of bail application be consigned to the record room.
