CHARGE

Here in I, Shri. Suryanarayana .S., B.A.L., L.L.B. Prl. Civil Judge & JMFC., Khanapur charge on you:

A-1 Ashok Suresh patil

A2. Laxman Sateri Patil

as under :

That on 03.05.2019 at night about 9:50 hours with inlimits of Khanapur Police Station,near Habbanahatti Village Belgavi-Chorla Road you accused being the driver of 407 Goods bearing Registration No.KA-22-4386 drove the said vehicle in a rash and negligent, so as endanger to human life and dashed to tree and thereby you have committed an offence punishable sec.279 of IPC within my cognizance.

2. Further it is alleged against you that on above said date, time and place you accused No.1 being the driver of the above said vehicle, drove the same without having any valid driving licence and thereby you have committed an offence punishable U/Sec. 3 r/w 181 of M.V.Act.

3. Further it is alleged against you that on above said date and place, due to accident you accused no.1 sustained simple injuries on head, and other places of your body and thereby you have committed an offence punishable sec.337 of IPC within my cognizance.

4. Further it is alleged that on above said date, time and place after causing accident you accused No.1 did not inform the said fact to nearest Police Station and thereby you have committed an offence punishable U/Sec. 134 r/w 187 of M.V.Act.

5. That on above said date, time and place you accused No 1 is found in possession of 4 plastic Can total 140 liters total amount 48,235/- without having any pass or permit or license and thereby you have committed an offence punishable U/Sec.32 of Karnataka Excise Act 1965 and within my cognizance.

6. That on the aforesaid date, time and place, you accused No.1 is found in possession of 48 Box of Royal Stag Company Containing 750 ml, 48 Box of IB Wishkey company 750 ml, 2 Box of MC Rum 750 ml, 5 Box of King fisher Tin 500ml, and 35 liters Country Sarai without having any pass or permit or license for selling by knowingly it has been illegally transported and thereby you have committed an offence punishable U/Sec.34 of Karnataka Excise Act 1965 and within my cognizance.

7. That on the aforesaid date, time and place, you accused No 2 being the owner of the 407 Gudd bearing No.KA-23-4386, has given said vehicle to accused No.1 to transport the illicit liquor 48 Box of Royal Stag Company Containing 750 ml, 48 Box of IB Wishkey company 750

ml, 2 Box of MC Rum 750 ml, 5 Box of King fisher Tin 500ml, and 35 liters Country Sarai 4 plastic Can total 140 liters total amount 48,235/- without having any pass or permit or license and thereby you have committed an offence punishable U/Sec.38(A) of Karnataka Excise Act within my cognizance.

8.That on the aforesaid date, time and place, you accused No 2 being the owner of the 407 Gudds bearing No.KA-23-4386, the said Accused No 1 even though you knew that he does not have an authorized driving license for driving the 407 Gudds of and thereby you have committed an offence punishable 5 R/w 180 M V Act within my cognizance.

And I hereby direct that you be tried by me on the above said charges.

(The charge is read over and explained to the accused person in the language known to him and is recorded duly in open court on this 3 rd day of October 022)
