Ld. counsel for the accused has submitted that upon the instructions from his client, he is admitting the genuinenesses and authenticity of the documents and correctness of fact as mentioned below and not disputing the same:-

(i) He is not disputing a factum of MLC No. 1353 Dated 04.01.2021 in respect of injured/deceased Rekha prepared by Dr. Mukesh Mandal, mentioned in list of witness attached with the charge-sheet at serial No. 6.

(ii) He is not disputing a factum of PM Report No. 18/21 Dated 05.01.2021 in respect of deceased Rekha prepared by Dr. V.K. Singh, mentioned in the list of witness attached with the charge-sheet at serial No. 7.

(iii) He is not disputing a factum of scaled site plan prepared by Ct. Naveen, mentioned in the list of witness attached with the charge-sheet at serial No. 11.

(iv) He is not disputing a factum of photographs taken by HC Munna Lal, mentioned in the list of witness attached with the charge-sheet at serial No. 13.

(v) He is not disputing a factum of Special Messenger, Ct. Jitender, mentioned in the list of witness attached with the charge-sheet at serial No. 15.

Ld. counsel for accused has further submitted that he has no objection if the abovesaid documents are exhibited in the prosecution evidence and are considered as admitted u/s 294 CrPC subject to without admitting the fact that the injuries have been caused by the accused.

The statement of Ld. counsel for the accused has been recorded separately to this effect.

Ld. Addl. PP for the State has submitted that in view of the statement of ld. counsels for accused persons, admitting the genuineness and authenticities of documents and correctness of facts, he drop the witnesses mentioned at serial no. 6, 7, 11, 13 & 15 in the list of witnesses attached with the charge-sheet.

Statement of ld. Addl. PP for the State has been recorded separately to this effect.

Keeping in view the statement of ld. Addl. PP for the State, **witnesses mentioned at serial no. 6, 7, 11, 13 & 15 are hereby dropped from the list of witnesses.**

Summons issued to PW Ram Dulari received back unserved with the report that no such person is residing at the given address.

Summons issued to PW Mukesh Kumar received back unserved with the report that he has left the given address.

Both the PWs be summoned afresh through SHO concerned for the NDOH.
