Substance of Plea

Case is disposed off accordingly.

Office is hereby Issue notice to I O produced the property.

The property shown at Sl.No.2 i.e. an amount of Rs.1,450/- of the charge sheet shall be confiscated to the state.

The property shown at Sl. No. 1 of the charge sheet being worthless, ordered to be destroyed.
