ORAL ORDER

This is an application for the grant of anticipatory bail under section 438 of the Cr.P.C., in connection with C. R. No. 1082 of 2021, registered with Malvani Police Station, relating to the offences

punishable under sections 326, 324, 323, 504, 506 (2) read with section 34 of the Indian Penal Code.

2 Perused the application, the say filed thereon and the documents relied upon in support thereof.

3 Heard the learned counsel for the applicant. None argued on behalf of the State.

4 It is submitted by the learned counsel for the applicant that there are limited allegations against the applicant. There are no criminal antecedents against him.

5 The only allegations against the applicant in the FIR are in respect of assaulting the informant and causing him to fall down on the ground. Looking to the limited role of the applicant, he is entitled to anticipatory bail, due to which, I proceed to pass the following order :

ORDER

1) The application for the grant of anticipatory bail is hereby allowed and it is hereby directed that in the case of arrest of the applicant **Abdul Satar Dafedar Shaikh @ Sattar**, in connection with C. R. No. 1082 of 2021, registered with Malvani Police Station, relating to the offences punishable under sections 326, 324, 323, 504, 506 (2) read with section 34 of the Indian Penal Code, he be released on bail, on his executing PR Bond of Rs. 15,000/- (Rupees Fifteen Thousand Only), with one or more sureties

in the like amount, on the conditions that the applicant shall not tamper with the prosecution witnesses in any manner and shall co-operate with the investigating agency.

2) The concerned Police Station be informed accordingly.

3) Anticipatory Bail Application No. 1848 of 2021 is hereby disposed of accordingly.
