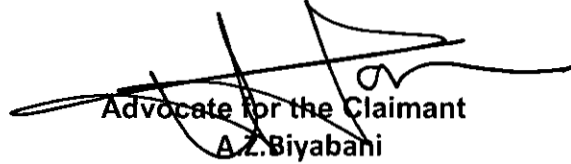

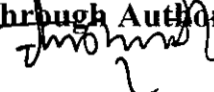

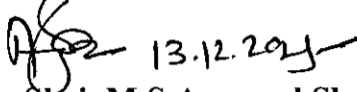
The dispute between the parties is compromised and the following award is

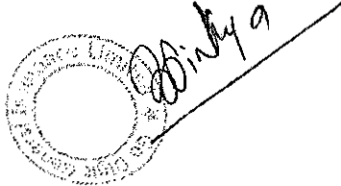

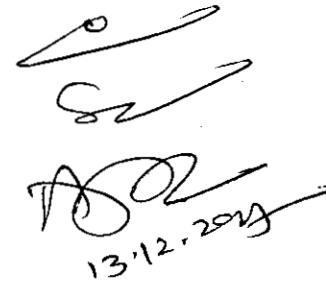

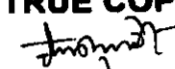
