you :**

as follows:-

That you accused No.1 at the instigation of you accused No.2 and 3 on 16/10/2024 at about 06.30 PM at the place situated in front of the house of Channa Basavana Gouda of Araliganuru Village had voluntarily caused hurt and grievous hurt to Somalingamma (C.W.6) by repeatedly assaulting on her neck by using knife and thereby committed an offence punishable under Sections 118(1) and 118(2) read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023 and within the cognizance of this court of Sessions.

2. That you accused No.1 at the instigation of you accused No.2 and 3 on 16/10/2024 at about 06.30 PM at the place situated in front of the house of Channa Basavana Gouda of Araliganuru Village did an act by using knife and piercing the same at the abdomen portion of Somalingamma, with such intention or knowledge and under such circumstances that, if by that

act, you had caused the death of Somalingamma, you would have been guilty of culpable homicide not amounting to murder and that you thereby committed an offence punishable under Section 109 read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023 and within the cognizance of this Court of Sessions.

3. That you accused No.1 at the instigation of you accused No.2 and 3 on 16/10/2024 at about 06.30 PM at the place situated in front of the house of Channa Basavana Gouda of Araliganuru Village by using knife piercing the same to the abdomen portion of Somalingamma, had caused the death of child in the womb of Somalingamma and that you accused thereby committed an offence punishable under Section 92 read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023 and within the cognizance of this Court of Sessions.

4. That you accused No.1 at the instigation of you accused No.2 and 3 on 16/10/2024 at about 06.30 PM at the place situated in front of the house of Channa Basavana Gouda of Araliganuru Village had committed criminal intimidation by threatening C.W.6 Somalingamma with injury to her person with intent to

cause alarm to the said C.W.6 Somalingamma and that you accused thereby committed an offence punishable under Section 351(1) read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023 and within the cognizance of this Court.

5. That on 16/10/2024 at about 06.30 PM at the place situated in front of the house of Channa Basavana Gouda of Araliganuru Village, you accused No.2 and 3 instigated the accused No.1 to cause hurt and grievous hurt to Somalingamma and thereby you accused committed an offence punishable under Section 49 read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023 and within the cognizance of this Court.

And I hereby direct that you shall be tried by this Court for the above said charge.
