That, on 29-09-2020 at about 11.15 a.m., you accused Nos.1 and 2 were transporting **36 Kilograms** of ganja in four plastic covers, worth **Rs.7,20,000/-** in an auto rickshaw bearing Reg. No.**AP-02/TE-0974 near Sri Annapurneshari Nagara Layout situated at Jagruthi Nagara, Cowl Bazaar, Ballari** illegally. You accused No.6 as per the say of you accused No.7, supplied 60 kilograms of ganja to deceased accused No.3 and accused No.7 in the above said auto through you accused No.1 and 2.

Further on the same day **at about 3.15 p.m.** deceased accused No.3 alongwith you accused Nos.4 and 5 found selling of ganja to the public at **Prashanth Nagara, Ballari** and also found in possession of 21 Kilograms of ganja worth **Rs.4,20,000/-**, which was kept in the plastic barrel in the Varandah of your

house and thereby you have committed an offence punishable under Section **20 (b) (ii) (C) of the Narcotic Drugs and Psychotropic Substances Act, 1985** and within the cognizance of this court.
