CHIEF EXAMINATION: BY P.P.

Since 9 years I am working as a Senior Medical Officer at Siruguppa.

2. On 27.2.2025 at 11.50 p.m Smt. Mukamma Wife of Chagappa visited our hospital on the history of assault. On examination I provided first aid then referred the patient to Government Hospital Ballari. Based on the X-ray report, CT Scan

report and other medical document I issued wound certificate. As per records I noticed the injuries.

1. Lacerated wound measuring 3x2x2 cm on both the elbow.
2. Lacerated wound measuring 6x3x2 cm over the back of right elbow.
3. Lacerated wound measuring 6x3x2 cm over the left hand.
4. Lacerated wound measuring 6x3x2 cm over the left shoulder .
5. Left distal 1/3 of radius bone fracture .
6. Tendor injury over the left wrist.

Injury No.1, 2, 3, 4 and 6 are simple in nature and injury No.5 is grievous in nature. Accordingly I issued a wound certificate. It is marked as **Ex.P.9**, the signature of witness marked as **Exp.9(a)**.

3. On 28.4.2025 the Hatcholli police made a request and produced Mo.2 (elige Mane) and sought an opinion that the injury

caused to Mukamma can be caused with the MO.2. The request letter is marked as **Ex.P.10**. I given my opinion that the injury mentioned in the wound certificate can be caused with a weapon which produced before me. Report is marked as **Exp.11** and signature is marked as **Ex.p11(a)**. I can identified the weapon which I examined.

CROSS EXAMINATION: Smt.H.R.J (L.A.D.C) counsel for accused

4. Patient narrated the history before me. Many people accompanied the patient to the hospital. I cannot remember their names. I issued wound certificate on 28.4.2025. It is true to suggest that lacerated wound can be caused if a person fall on hard surface. It can be caused accidentally.

5. It is true to suggest that SL.No.5 injury can be caused out of fall and out stretching of hand. It is false to suggest that I have not stated age of the injury. It is false to suggest that I issued a wound certificate without looking into the document,

patient and weapon. It is false to suggest that to help the Police I am deposing false before the court.
