CHIEF EXAMINATION BY :- LEARNED P.P.

I was worked as a Casualty Medical Officer in VIMS, Ballari, between 2020 to 2023.

On 12-9-2021 the injured by name Anil aged 22 years, came to the Hospital with alleged history of assault on dated 12-9-2021 at about 10.00 PM near Housing Board Park, Gandhi Nagar, Ballari.

I have treated the said patient at about 10.40 PM on the same day. On examination I found that the patient was conscious and oriented and also found that, the cut lacerated wound above left eyebrow measuring 4X2 Cm. I am of the opinion that, the said

injury is simple in nature. To that effect I have issued wound certificate. Witness identified the same which bears his signature. Same is marked as Ex.P.11 and signature is marked as Ex.P. 11(a). I have corrected in the Ex.P-11 as year is printed as 2020 instead of 2021. I have put my initial on correction.

On 12-9-2021 the injured by name Mareenna, aged 35 years, came to the Hospital with alleged history of assault on dated 12-9-2021 at about 10.00 PM near Housing Board Park, Gandhi Nagar, Ballari.

I have treated the said patient at about 10.45 PM on the same day. On examination I found that the patient was conscious and oriented and also found that, the cut lacerated wound above right eyebrow measuring 3X2 Cm. I have referred the patient for C.T Scan and perused the same bearing No.CT No.1479 as per the said report no significant abnormality detected. I am of the opinion that, the said injury is simple in nature. To that effect I have issued wound certificate. Witness identified the same which bears his signature. Same is marked as Ex.P.12 and signature is marked as Ex.P.12(a). I have corrected in the Ex.P-12 as year is printed as 2020 instead of 2021. I have put my initial on correction.

I have also given the opinion report on 11-11-2021 with the requisition of IO dated 2-11-2021. Witness identified the requisition same is marked as Ex.P-13 and the signature is marked

as Ex.P-13(a). Witness identified that, certificate of examination same is marked as Ex.P-14 and signature is marked as Ex.P-14(a). Witness identified the MO 1 and 2. The injury mentioned in Ex.P-11 and 12 can be caused by weapon like MO 1 and 2.

Cross examination by Sri.SRP and PRB Advocates for accused persons.

MO 1 and 2 types of weapon are available at place of construction building. There is a possibility to sustained the injury mentioned in Ex.P-11 and 12, if a person fell down on hard surface. I have issued the intimation of the assault when injured came for treatment to the out post police station. I have sent the MLC report to the out post police station. It is false to suggest that, I have given false opinion report to obelize the IO. It is false to suggest that, I have not treated any injured.
