ORDERS

The petitioner has filed this petition U/s.13(3) of Karnataka Registration of Births and Deaths Act, 1969 to direct the respondent to issue Birth certificate of his son.

2. Brief facts of petitioner's case are that :-

The petition filed by the Petitioner U/s.13(3) of Karnataka Registration of Births and Deaths Act, 1969, praying to direct the Respondent to register the birth date of his son Ajjayya S/o H. Sanna Chittappa as 03.07.2015, at K. Gollarahatti Village, Sandur Taluk, Ballari District, in the register maintained by the Respondent. Because of lack of knowledge, they have not entered birth date of his son with respective Authorities. He required the Birth Certificate for the purpose of education. When he had approached respondent for issuance of Birth Certificate of his son, they issued an endorsement stating that, since no report has been made regarding birth date of petitioner's son, there was no entry found in their Birth Register and hence they are unable to issue the Birth Certificate. Hence, this petition.

3. After service of summons, respondent remains absent.
Hence, placed *exparte*.

4. The petitioner got examined himself as PW1 and also sworn an affidavit and relied on 3 documents, which are marked as Ex.P1 to Ex.P3.

5. Heard learned counsel for petitioner.

6. Now, the points that arises for my consideration are:-

1. Whether the petitioner has made out grounds for issuance of direction to the respondent to make an entry in the Birth and Death register of the respondent's office with regard to date of birth of his son, as 03.07.2015?

8. **POINT NO.1:-** In order to prove the above point, the petitioner relies on his oral as well as documentary evidence which

were marked as Ex.P1 to Ex.P3. Ex.P.1 is the Non-Availability Certificate, Ex.P2 is the Attested copy of Aadhar card of petitioner and Ex.P3 is the School certificate of petitioner's son. Ex.P.3 is the School certificate of petitioner's son which discloses that the date of birth of his son is 03.07.2015. The respondent has not discredited the statement of petitioner given on oath with regard to birth date of his son. Anyhow, no contrary evidence is placed to disbelieve the versions of PW.1, hence evidence of PW.1 remains unchallenged. Further nothing holds from disbelieving the version of PW.1. From both oral and documentary evidence, the petitioner has clearly established that, his son was born on 03.07.2015. Hence, Point No.1 is answered in **Affirmative.**

9. **POINT NO.2:-** Reasons assigned to Point No.1 resulted in following:-

: O R D E R :

The petition is hereby allowed.

The respondent is directed to make entry with respect to the date of birth of petitioner's son - Ajjayya S/o H. Sanna Chittappa as 03.07.2015, at

K. Gollarahatti Village, Sandur Taluk, Ballari District, in the concerned register and issue the birth certificate to the petitioner after collecting necessary fee.
