CLAIM:

- a) To declare the plaintiff is an absolute owner of the suit schedule lands bearing Sy.No.61,62/A, 62/C, 63/A, 63/C, 44 and 46 measuring 5-14,0-15,2-63,5-24,3-95, 0-90 and 2-83 acres respectively situated at Raravi village, Siruguppa Taluk.

- b) To issue necessary direction to the Thasildhar, Siruguppa for transfer of mutation in respect to suit schedule lands bearing Sy.No.61,62/A,62/C, 63/A, 63/C, 44 and 46 measuring 5-14,0-15,2-63,5-24,3-95, 0-90 and 2-83 acres respectively situated at Raravi Village, Siruguppa Tq. in favour of plaintiffs and incorporate the plaintiffs name in the record of rights on the basis of registered sale deed dt: 06-06-1975.
- c) To cancel the mutation order M.R.No.H260/2011-2012 dt:30-05-2012 is not binding to the plaintiffs and same to set aside and declare null and void and to issue necessary direction to the Tahasildhar, Siruguppa, for ratification of record of rights and incorporate the plaintiffs name to an extent of 0-90 acres in survey number 44 in Raravi village in record of rights by deleting defendant No.3-Kudulur Shivanna s/o Late Kudulur Yankappa.
- d) For cost of the suit
- e) For grant of such other relief's.

It is further ordered and decreed that the Tahasildhar at Siruguppa is hereby directed to make necessary entry in respect of the landed properties bearing Sy.No. 61,62/A,62/C,63/A,63/C,44 and 46 measuring 5-14,0-15,2-63,5-24,3-95, 0-90 and 2-83 acres respectively situated as Raravi village, Siruguppa Taluk, Ballari District, in favour of the plaintiffs and incorporate the plaintiffs name in the record of rights on the basis of registered sale deed dated 06-06-1975 within three months from the date of receipt of this order.

It is further ordered and decreed that Tahasildhar at Siruguppa is further directed to make rectification in the record of rights and incorporate the plaintiffs name to the extent of 0-90 cents in survey number 44 situated at Raravi village, Siruguppa Taluk, Ballari District by deleting the name of defendant No.3 Kudulur Shivanna S/o Late Kudulur Yankappa.
