CHARGE

I, Deshpande G.S., B.Com., LL.M., Prl. District and Sessions

Judge, Bagalkot, do hereby charge you:

- 1) Gyanappa S/o Chandrappa Pujari,
- 2) Chandrappa S/o Sannakariyappa Pujari  
@ Tegginamani,
- 3) Hanamappa S/o Chandrappa Pujari,
- 6) Dyavappa S/o Balappa Pujari @ Kati,  
All are R/o: Chatnihal, Tq: Ilkal.

as follows:

You the accused on 10.1.2022 in between 10.30 p.m., and 11.00 p.m., in the house residing by the accused No.1 situated at Chatnihal village with common intention assaulted deceased Allasab with hands and kicked on his face and chest, the accused No.6 assaulted him with hands and kicked and accused No.2 assaulted C.W.6 with hands and accused No.1 kicked C.W.6 and voluntarily caused hurt and thereby

committed the offence punishable under Section 323 read with Section 34 of IPC and within the cognizance of this Court.

Secondly, on the aforesaid date, time and place, you all the accused in furtherance of your common intention, the accused No.1 assaulted deceased Allasab with the handle of the spade and accused No.2 and 3 assaulted him with clubs on face and head and voluntarily caused hurt and thereby committed the offence punishable under Section 324 read with Section 34 of IPC and within the cognizance of this Court.

Thirdly, on the aforesaid date, time and place, you all the accused you the accused No.7, 11 to 14 and 19 dragged the sari worn by her with intent to disrobe and thereby committed the offence punishable under Section 354B read with Section 34 of IPC and within the cognizance of this Court.

Fourthly, on the aforesaid date, time and place, you all the accused in furtherance of your common intention, with an intention or knowledge to commit the murder of Allasab, the accused No.1 assaulted him with the handle of spade and accused No.2 and 3 assaulted him with clubs on his face and head and committed his murder and thereby committed the

offence punishable under Section 302 read with Section 34 of IPC and within the cognizance of this Court.

Lastly, on the aforesaid date, time and place, you all the accused in furtherance of your common intention, abused the deceased Allasab in filthy language and intentionally insulted and thereby gave provocation to him intending that such provocation would cause him to break the public peace or to commit any other offence and thereby committed the offence punishable under Section 504 read with Section 34 of IPC and within the cognizance of this Court.

I hereby direct that you be tried by this court on the above said charge.
