:CHARGE:

It is hereby charge you as follows:

You the accused named above, on 02.10.2017 at 01.00 p.m. near Durga Devi Temple of Konnur village within the limits of Ilkal Rural Police Station common object to commit offence you accused persons made unlawful assembly and thereby committed the offence Punishable under Section 143 R/W 149 of IPC and within the cognizance of this court.

Secondly, that on the above said date, time and place you accused persons in furtherance of your common object committed rioting and thereby committed the offence Punishable under Section 147 R/W 149 of IPC and within the cognizance of this court.

Thirdly, that on the above said date, time and place you accused persons in furtherance of your common object committed rioting armed with deadly weapons, started altercation with C.W.1 and thereby committed the offence Punishable under Section 148 R/W 149 of IPC and within the cognizance of this court.

Fourthly, that on the above said date, time and place you accused persons in furtherance of your common object by assaulting with hands to CW.1, 8 to 11 causing bodily pain and injuries and thereby committed the offence Punishable under Section 323 R/W 149 of IPC and within the cognizance of this court.

Fifthly, that on the above said date, time and place you accused persons in furtherance of your common object assaulted with wood and sticks CW.8, 9 and 11 and causing bodily pain and injuries and thereby committed the offence Punishable under Section 324 R/W 149 of IPC and within the cognizance of this court.

Sixthly, that on the above said date, time and place you accused persons in furtherance of your common object you accused No.1 dragged the mother-in-law of the CW.1/complainant i.e., CW.4 Dyamavva W/o. Ramanna

Ambiger and her daughter CW.5 Manjula D/o. Ramanna Ambiger by holding their hair and saree and made them to fall on the ground, with the intention of disrobing or compelling them to be naked and thereby committed an offence punishable under section 354(B) R/W Sec.149 of IPC and within the cognizance of this court.

Seventhly, that on the above said date, time and place you accused persons in furtherance of your common object abused in filthy language by instigating complainant and other witnesses to commit breach of public peace and thereby committed the offence Punishable under Section 504 R/W 149 of IPC and within the cognizance of this court.

Lastly, that on the above said date, time and place you accused persons in furtherance of your common object among you accused persons threatened with dire consequence to complainant and charge sheet witnesses and thereby committed the offence Punishable under Section 506 R/W 149 of IPC and within the cognizance of this court.

And I hereby directed that you be tried by this court on the said charges.
