CHARGE

I, N.V. Vijay, B.A. LL.B. (Hons.), Pril. District and  
Sessions Judge, Bagalkote, do hereby charge you:

- 1) Channabasayya Adavayya Hiremath,  
Age: 42 years, Occ: farmer,  
R/o: 22<sup>nd</sup> cross, Vidyagiri, Bagalkot.
- 2) Suma Channabasayya Hiremath,  
Age: 34 years, Occ: Household work,
- 3) Ambaju Ashok Zingade,  
Age: 36 years, Occ: Labourer,
- 4) Vinayak Ashok Zingade,  
Age: 36 years, Occ: Labourer,
- 5) Santabayi Ashok Zingade,  
Age: 56 years, Occ: Household work,  
All are R/o: Sector No.10, Navanagar,  
Bagalkot.

as follows:

That complainant is none other than the wife of you A-1, on account of you A-1 having illicit relationship with you A-2 frequent quarrels took place between the complainant and you A-1 and you A-1 on the pretext of this, on 07.03.2024 at about 9.00 p.m., came to the house of complainant situated at 22<sup>nd</sup> cross, Vidyagiri, in Bagalkot along with you A-2 to A-5, formed yourselves into an unlawful assembly picked up quarrel with complainant and your common object was to abuse, assault and threaten and attempt to commit murder of the complainant and thereby committed the offence punishable under Section 143 read with section 149 of IPC and within the cognizance of this Court.

Secondly, on the aforesaid date, time and place, you all the accused in furtherance of your common object, abused the complainant in filthy language and intentionally insulted and gave provocation to her knowing it to be likely that such provocation would cause her to break the public peace or to commit any other offence and thereby committed the offence punishable under Section

504 read with Section 149 of IPC and within the cognizance of this Court.

Thirdly, on the aforesaid date, time and place, you all the accused in furtherance of your common object, among yourselves, you A-1 assaulted the complainant with your hands and you A-2 and A-5 dragged the complainant by holding her tuft and voluntarily caused simple hurt to her and thereby committed the offence punishable under Section 323 read with Section 149 of IPC and within the cognizance of this Court.

Fourthly, on the aforesaid date, time and place, you all the accused persons in furtherance of your common object, among yourselves, you A-3 and A-4 with an intention to disrobe the complainant/C.W.1, dragged her Saari and outraged her modesty and thereby committed the offence punishable under section 354(B) read with section 149 of IPC and within the cognizance of this Court.

Fifthly, on the aforesaid date, time and place, you all the accused in furtherance of your common object, among yourselves, you A-1 during the process of quarrel, with an intention to commit murder of complainant, burned the hand of complainant with Cigarette and sat on the chest of

complainant, squeezed her neck and voluntarily caused hurt with knowledge that if your said act caused her death, you would be guilty of murder and thereby committed the offence punishable under Section 307 of IPC and within the cognizance of this Court.

Lastly, on the aforesaid date, time and place, you all the accused in furtherance of your common object, criminally intimidated the complainant and thereby committed the offence punishable under Section 506 read with Section 149 of IPC and within the cognizance of this Court.

I hereby direct that, you be tried by me on the aforesaid charges.
