CHARGE

I, N.V. Vijay, B.A. LL.B. (Hons.), Pril. District and
Sessions Judge, Bagalkote, do hereby charge you:

- 1) Sangappa S/o Yamanappa Karapadi,
Age: 35 years, Occ: Farmer,
- 2) Hanamappa S/o Yamanappa Karapadi,
Age: 20 years, Occ: Farmer,
- 3) Shivappa Urf Shivanand Yamanappa
Karapadi, Age: 50 years, Occ: Farmer,
- 4) Basappa S/o Yamanappa Karapadi,
Age: 37 years, Occ: Farmer,
All are R/o: Chittawadagi, Tq: Hungund.

as follows:

That on 02.03.2020 at about 5.30 p.m., near the
land of one Mariyappa S/o Rayappa Hadimani, R/o
Huchanur situated at Chittawadagi village you accused
No.1 to 4 with your common intention on account of your

previous enmity with complainant and his son/C.W.4 with regard to previous quarrel took place in Chittawadagi village fair wrongfully restrained the C.W.4 and thereby committed the offence punishable under Section 341 read with Section 34 of IPC and within the cognizance of this Court.

Secondly, on the aforesaid date, time and place, you the accused No.1 to 4 with your common intention picked up quarrel with C.W.4 and assaulted him with your hands and voluntarily caused simple hurt and thereby committed the offence punishable under Section 323 read with Section 34 of IPC and within the cognizance of this Court.

Thirdly, on the aforesaid date, time and place, you the accused No.1 to 4 with your common intention assaulted the C.W.4 with dangerous weapon like stone and voluntarily caused grievous injury to him and thereby committed the offence punishable under Section 324 read with Section 34 of IPC and within the cognizance of this Court.

Fourthly, on the aforesaid date, time and place, you the accused No.1 to 4 with your common intention abused the C.W.4 in filthy language and intentionally insulted and gave provocation to him knowing it to be likely that such provocation would cause him to break the public peace or to commit any other offence and thereby committed the offence punishable under Section 504 read with Section 34 of IPC and within the cognizance of this Court.

Lastly, on the aforesaid date, time and place, you the accused No.1 to 4 with your common intention criminally intimidated the C.W.4 with dire consequences and thereby committed the offence punishable under Section 506 read with Section 34 of IPC and within the cognizance of this Court.

I hereby direct that, you be tried by me on the aforesaid charges.
