CHARGE

I, G.A.Mulimani, M.A., LL.M., II Additional District and
Sessions Judge, do hereby charge you:

1. Mutappa S/o Jayappa Hulageri,
Age: 24 years, Occ: Farmer,
R/o Gorabal, Tq: Hungund, Dt: Bagalkot.
3. Sangappa S/o Jayappa Hulageri,
Age: 33 years, Occ: Farmer,
R/o Gorabal, Tq: Hungund, Dt: Bagalkot.
4. Siddavva Jayappa Hulageri,
R/o Gorabal, Tq: Hungund, Dt: Bagalkot.

as follows:-

You the accused named above, on 22.06.2018 at

about 1.15 pm to 2.00 pm, in the land of accused persons situated at Gorabal village within the limits of Ilkal Police Station, in furtherance of your common intention picked up quarrel with CW-4-Shantamma while she collecting the grass, at that time assaulted her by means of chappal, kicked her and voluntarily caused injuries and committed an offence punishable under S.323 read with S.34 of I.P.C., and within the cognizance of this court.

Secondly, you the accused named above, on the aforesaid date, time and place, in furtherance of your common intention, dragged C.W.4 by hold her hands and gave fist on her left ribs with in intention to disrobe her and thereby committed an offence punishable under S.354 read with S.34 of I.P.C., and within the cognizance of this court.

Thirdly, you the accused named above, on the aforesaid date, time and place, in furtherance of your common intention, dragged C.W.4 by hold her hands also pulled her hair-bun and used criminal force with in intention

to dishonor her and thereby committed an offence punishable under S.355 read with S.34 of I.P.C., and within the cognizance of this court.

Fourthly, you the accused named above, on the aforesaid date, time and place, in furtherance of your common intention, abused the CW-1 in filthy language stating as "ಮಾದರ ಸೂಳೆ ಮಗನೇ" and provoked him knowing it to be likely that such provocation will cause him to break public peace and thereby committed an offence punishable under S.504 read with S.34 of I.P.C., and within the cognizance of this court.

Fifthly, you the accused named above, on the aforesaid date, time and place, in furtherance of your common intention knowing fully well that CW-1 belongs to scheduled caste, abused them in filthy language taking the name of their caste stating as "ಮಾದರ ಸೂಳೆ ಮಗನೇ" in the name of his sub caste with an intention to insult and degrade him in the public view and caused the atrocity against the C.W.1. and

thereby committed an offence punishable under S.3(1)(s) of S.C. and S.T. (P.O.A.) Amendment Act, 2015 read with S.34 of I.P.C., and within the cognizance of this court.

Lastly, you the accused named above, on the aforesaid date, time and place, in prosecution of your common intention, by committing the offences punishable under S.323, 324, 355 of I.P.C. and knowing fully well that the complainant is the person belonging to scheduled caste, thereby committed an offence punishable under S.3(2)(va) of S.C. S.T. (P.O.A.) Act read with S.34 of I.P.C., and within the cognizance of this court.

Therefore, I hereby direct that you be tried by this court on the above said charge.
