CHARGE

I, **SRI. MASTER R.K.G.M.M. MAHASWAMIJI, M.A., L.L.M.**, Prl. District & Sessions Judge, Bagalkote, do hereby charge you:

- 1) Sri. **Ayyappa** S/o Muniyappa Malagavi,
Age: **60** years, Occ: Farmer,
- 2) Smt. **Muniyavva** W/o Ayyappa Malagavi,
Age: **55** years, Occ: Housewife,
- 3) Sri. **Ravi** S/o Ayyappa Malagavi,
Age: **21** years, Occ: Farmer,
All are R/o: Kirasur village,
Tq: & Dist: Bagalkote.

as follows:

1. That on 07.09.2025 at about 1 p.m. near Basavanna Temple situated at Kirasur village, you A-1 to A-3 on account of your previous enmity with the complainant/CW.1 pertaining to sharing of property, when CW.1 proceeding on his motorcycle, among

yourselves, you A-1 and A-3 stopped the motorcycle of CW.1, picked up quarrel with him and **abused** him in filthy language "ಲೇ ಬೋಸಡಿ ಮಗನಾ" and intentionally insulted and gave provocation to him knowing it to be likely that such provocation would cause him to break the public peace or to commit any other offence and **thereby** committed an offence p/u/sec.**352** read with section 3(5) of B.N.S and within the cognizance of this Court.

2. Secondly, on the aforesaid date, time and place, you A-1 to A-3 in furtherance of your common intention, among yourselves, you A-1 and A-3 assaulted the CW-1 **with your hands** and you A-2 kicked him on his stomach and voluntarily caused simple hurt to him and **thereby** committed an offence p/u/sec.**115(2)** read with section 3(5) of B.N.S. and within the cognizance of this Court.

3. Thirdly, on the aforesaid date, time and place you A-1 to A-3 in furtherance of your common intention, among yourselves, you A-2 **wrongfully restrained** the complainant/CW.1 from moving further and pushed him on the ground and **thereby** committed an offence

p/u/sec.**126(2)** read with Section 3(5) of B.N.S. and within the cognizance of this Court.

4. Fourthly, on the aforesaid date, time and place, you A-1 to A-3 in furtherance of your common intention, among yourselves, you **A-1** assaulted the CW-1 with deadly weapon like **stone** on his left palm and right ear and voluntarily caused hurt to him and **thereby** committed an offence p/u/sec.**118(1)** read with Section 3(5) of B.N.S. and within the cognizance of this Court.

5. Lastly, on the aforesaid date, time and place, you A-1 to A-3 in furtherance of your common intention, criminally **intimidated** the complainant/CW-1 with intent to cause alarm to him and **thereby** committed an offence p/u/sec.**351(2)** read with section 3(5) of B.N.S. and within the cognizance of this Court.

And therefore, I hereby direct that, you be tried by me on the aforesaid charges.
