WRITTEN STATEMENT U/O VIII RULE 1 and 2 with Counter  
Claim U/O VIII Rule 6(A) OF C P C

Herein, the Advocate for Defendant begs to submit the Written Statement as under.

- 1) That the contents of the Plaint filed for Dissolution of marriage are total false, vexatious and not tenable in law of facts and Evidence on record and this defendant denied the same except those that are admitted below.
- 2) It is true that the plaintiff is defendant got married on 25/05/2016 before the house of plaintiff at Sulibhavi villiage. Out of their wedlock there are no any issues as stated in the Para 2 of plaint.
- 3) It is true that after marriage, plaintiff went to defendant house to lead marital life, but it is totally false that the plaintiff lead marital life with defendant about 2 years that too struggle with defendant. It is totally false that defendant was used to harass the plaintiff without any just reason. It is false to say that defendant never shows his love and kindness towards the plaintiff. It is totally false to say that defendant was used to physically and mentally abuse to the plaintiff and on several occasions and it is totally false to say that there are some instances that some elders and well wishers of plaintiff and defendant have advised the defendant not to abuse the plaintiff. The plaintiff must prove with strict proof. It is further false to say that plaintiff continued to tolerate all such abuse, torture for the sake of family well being. Plaintiff always made efforts to please the defendant. Plaintiff did what the defendant wanted and lived how the defendant wanted her to live. The plaintiff did everything possible to make defendant happy to maintain the peace in family, but all efforts went in vain as the defendant not ready to stop abusing the plaintiff.

- 4) It is totally false that what was stated in the Para no 4, the plaintiff must prove with strict proof that the defendant was beaten up her, and other what was stated in the para no 4.
  - 5) That, what the content in the para no 5 is stated by the plaintiff is totally reversed statement by the defendant for the marital relationship with the plaintiff.

**TRUE FACTS:**

- 1) It is true that the plaintiff and defendant are the husband and wife. It is true that the marriage solemnized on 25/05/2016 before the house of plaintiff at Sulibhavi villiage and out of wedlock there is no any issues.
- 2) After marriage the plaintiff has come to this defendant house to lead marital life with defendant only for 5 months, after 5 months the plaintiff himself left the house of defendant without any reason and settled in her mother's house.
- 3) The defendant visited several times to call her to lead marital life, but the plaintiff herself avoided to word of defendant and postpone to come with the defendant.
- 4) The defendant waited for some days, and further visited to house of her mother house with the elder of family of defendant to call her for lead the marital life, but to give the respect of elder she has returned to the defendant only for 2 to 3 months, but the plaintiff herself went on to their parent house without informing the parent of defendant or to the defendant.
- 5) The defendant once again has visited with the elder of the village of defendant and advice her to lead the marital life with the defendant. The plaintiff had denied coming with voice of the elders of the village and refusing to come.
- 6) For the reason above the defendant has doubt of the behavior of the plaintiff that she has affair with the person and enquire about fact with the relation of the defendant in her village and defendant has come to know that she has affair with the another person. After this incident the defendant has mentally harassed for the behavior of the plaintiff.
- 7) After enquiry to the parent of the plaintiff, the parent has told that, now she has absconded with the person, the complaint has also been filled in Belgaum A P M C police station by Cr. No 97/2021, and replied the defendant that "You see your way ". For this reason the defendant has defamed with this incident. The defendant has not valued and respect in the society and mentally depressed with the incident.

8) After the incident the defendant with the elders of the village the as per caste system has sent the " Kulla Naama " as on dated 23/09/2021 sent by the registered post to plaintiff parent address. Same has been served to the plaintiff, but reply has not been received till today.

9) Therefore the defendant mentally decided to dissolve his marriage with plaintiff through legal process. The relationship of defendant with plaintiff could not pull on well owing to various differences. There is no chance of reconciliation or to continue the marital relationship of marriage or resumption of normal marital life and relationship in future.

**PRAYER:**

Hence for the reason above, the Hon'ble court may kindly be pleased to pass decree by dissolving the marriage solemnized between the plaintiff and defendant on 25/05/2016 before the house of plaintiff at Sulibhavi village in the interest of justice and equity.


