1. Defendants No.1, 2 & 4 have filed IA.No.V U/o. XI Rule 14 R/w Sec.151 of CPC seeking direction against the Tahasildar Jamkhandi to produce the documents viz., **"Entire Varadi files of both ME.No.6092 & 6285 of Kunchanur village, Tq: Jamkhandi"**.

2. In support of above application, defendant No.4 has mainly stated that, aforesaid documents are very much necessary to adjudicate the matter in dispute. On 06.08.2025, he had applied for certified copies of said documents, but the Tahasildar Jamkhandi had not responded to his application. Hence he is

constrained to file this application. With this, he prayed to allow above application.

3. On the contrary, counsel for the plaintiff submitted no objection to above application.

4. Heard. Perused application and all other materials on record. Upon going through the contents of application and all other materials on record, the points that would arise for consideration are as under;

POINTS

1. Whether defendants No.1, 2 & 4 have made out grounds to allow I.A.No.V ?

2. What order ?

5. This court answers to above points as under:

REASONS

6. Point No.1: Defendants No.1, 2 & 4 have filed this application to issue direction to the Tahasildar Jamkhandi to produce aforesaid documents. In support of above application counsel for the defendants has produced a received copy of

application, which indicates that, defendant No.4 had applied for aforesaid documents. It is to note here that, said defendant has not stated anything about the result of his aforesaid application.

7. On the contrary, counsel for the plaintiff has produced an endorsement issued by the Tahasildar Jamkhandi, which clearly indicate that, the "Varadi & Mutation" pertaining to properties bearing No.6285 & 6092 are not available in the office. When such being the fact, if above application is allowed and issued direction as sought for, no purpose will be served. Therefore this court is of opinion that, in view of above facts & circumstances and in the light of endorsement issued by the Tahasildar Jamkhandi, the present application is not tenable. Accordingly point No.1 is answered in the negative.

8. Point No.2: In view of above findings, the court proceeds to pass the following:

ORDER

I.A.No.V filed U/o.XI Rule 14 R/w
Sec.151 of CPC by the defendants No.1,
2 & 4 is hereby rejected.

No order as to costs.
