As follows:

That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti were a member of unlawful assembly the common object of which was to extort commodities and money from CW-1 and thereby committed an offence punishable u/Sec. 143 of IPC within the cognizance of this court;

2. That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti were a member of unlawful assembly and in prosecution of the common object to extort commodities and money from CW-1 committed an offence of rioting punishable u/Sec. 147 of IPC and within the cognizance of this court;

3. That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti were a member of unlawful assembly and were at that time armed with long and knife and thereby committed an offence punishable u/Sec. 148 of IPC and within the cognizance of this court;

4. That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti committed criminal intimidation by threatening CW-1 with injury to his person, repetition on property of his above said tea shop, with intent to cause alarm to CW-1 by keeping the long at his neck and keeping the knife at his lip and to cause CW-1 to give you cigerate and other commodities without any payment and that you have thereby committed an offence punishable u/ Sec. 506 of IPC and within the cognizance of this court;

5. That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of

Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti intentionally insulted the said CW-1 by abusing him in filthy language and thereby gave provocation to CW-1 intending to that such provocation will cause CW-1 to break public peace and thereby committed an offence punishable u/Sec. 504 of IPC within the cognizance of this court;

6. That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti, when CW-1 refused to give you cigerate and other commodities without payment, voluntarily caused hurt to CW-1 by assaulting him by your hands and legs and thereby committed an offence punishable under Section 323 read with Section 149 of IPC within the cognizance of this court.

7. That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti, wrongfully restrained CW-1 from proceeding outside his said tea shop and thereby

committed an offence punishable under Section 341 of IPC and within the cognizance of this court.

8. That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti, did an act of assaulting CW-1 at the right portion of his chest by using long with such intention and under such circumstances that by that act you had caused the death of CW-1, you would have been guilty of murder and thereby committed offence punishable under Section 307 read with Section 149 of IPC within the cognizance of this court.

9. That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti, committed mischief by causing wrongful loss or damage to the property of CW-1 by breaking the bottle jars of his shop of worth of more than Rs.50/- and thereby committed an offence punishable under Section 427 read with Section 149 of IPC within the cognizance of this court;

10. That you accused No.2, 4, 7 with accused No.3 and J-1 to J-3 the juveniles who are conflict with law, on 04.03.2022 at about 4-30 p.m., near the Tea shop of Nemichand, S/o Parasmal (CW-1) situate at Pipeline Road, Chikkagollarahatti were a member of unlawful assembly, and in prosecution of the common object to extort commodities and money from CW-1 committed offences punishable under Sections 341, 323, 504, 506 and 307 of IPC which offence you knew to be likely to be committed in prosecution of the above said common object of the assembly and you being a member of such assembly at the time of committing of that offence are thereby guilty of an offence punishable under Section 149 of IPC within the cognizance of this court;

And, I hereby direct that you shall be tried by this Court for the above said charge.
