As follows:

That you accused No.1 along with three other accused persons namely Yogesh @ Yogi, Basavaraju @ Basava and Siddesh K. E @ Siddu at about 11-30 p.m. on 13.10.2019, at the place of steps of shop premises of APMC Yard of Vaderahalli Village situated on the public road which runs between Makali - Huskuru, you and the above said three others came in Motor Car bearing No. KA 13 C 437, which was robbed on the very same day and which belongs to CW-6 Basavaraju, S/o Channabasappa and quarelled with CW-1 Sri. Harish, S/o Venkatesh, CW-2 Sri. Jayaprakash, S/o Narasimha Murthy and CW-5 Sri. Anil Kumar, S/o Narasimhaiah besides assaulting CW-1 with knife and thereby causing bleeding injury to the said CW-1 and in furtherance of the said act, you accused No.1 and three others robbed CW-1 of his neck gold chain being 18 grams and mobile phone, that CW-5 was robbed off cash amount of Rs.6,000/- and mobile phone and thereby committed an offence punishable under Section 397 of IPC and within the cognizance of this court of session.

And, I hereby direct that you shall be tried by this Court for the above said charge.
