do hereby charge you the accused;

A.1 Vasu K @ Andrahalli Vasu,  
S/o Late Military Krishnappa,  
Aged about 33 years,  
R/at: No. 299,  
Dhanalakshmi Bar Opp. Road,  
Andhrahalli Main Road, Benglauru.

A.2 Vikas S S/o Late Shivalingaiah,  
Aged about 33 years,  
R/at: No. 107,  
6<sup>th</sup> Main Road, 6<sup>th</sup> Cross,  
Sriramnagar, BSK 3<sup>rd</sup> Stage,  
Sai Garments, Papareddy Palya,  
Bengaluru.

as follows:-

That on 15.01.2021 at about 7.30 p.m., near double road situated towards Sir.M. Visweswaraiah Road within the jurisdiction of Byadarahalli Police Station, you accused No.1 and 2 along with split-up accused No.3 to 5 were holding deadly weapons like 2 Longs, 2 wooden clubs and chilly-powder packet and were making preparations to commit dacoity of the passerby and thereby committed the offence punishable U/S.399 IPC and within the cognizance of this Court of Sessions.

Secondly, that on the above said date, time and place, you accused No.1 and 2 along with split-up accused No.3 to 5 have assembled for the purpose of committing dacoity by holding deadly weapons like 2 Longs, 2 wooden clubs and chilly-powder packet and thereby committed the offence punishable U/S.402 IPC and within the cognizance of this Court of Sessions.

Thirdly, that on the above said date, time and place, you accused No.1 and 2 along with split-up accused No.3 to 5 possessed iron Longs which is described as Arm as per S.2(c) of the Arms Act, 1959 without any license or permit and thereby violated S.7 of the Arms Act and thereby committed the offence punishable under S.25(1B)(b) R/W. S.4 of the Arms Act, 1959 and within the cognizance of this Court of Sessions.

And I hereby direct that you be tried on the above said charges.
