That you accused No.1 and 2 on 19.02.2025 at about 9-20 p.m., near the railway track which runs near Aluru and Narasipura road, having summoned Loganathan from Shoolagiri near the said railway track and ***over the matter of marriage between you accused No.1 and 2 and over the consequential quarrel between Loganathan and you accused No.1 and 2***, committed murder intentionally causing the death of said Loganathan by assaulting on his head and neck portions by using Machhate and thereby you accused No.1 and 2 committed an offence punishable under Section 103(1) read with Section 3(6) of BNS, 2023 within the cognizance of this court.

That you accused No.1 and 2 at the above said place, on the above said date and time having committed the murder of the above said Loganathan in the above said manner, ***with the help of you accused No.3 shifted the dead body of Loganathan from the place of his death to the nearby railway track and placed the dead body on the railway track*** so that

the said dead body be run over by any train and thereby caused the evidence of murder to disappear with an intention to screen you accused No.1 and 2 from legal punishment and thereby by committed the offence punishable U/s. 238(1) read with Section 3(6) of BNS within the cognizance of this court.

And, I hereby direct that you all be tried by this Court for the above said charge.
