As follows:

First, that you accused No.8 enraged by act of deceased Girish in not repaying the amount lent by you and by his act of displaying your mobile phone number in public places, you before 23.10.2020 conspired with accused No.9 Arun Kumar and you accused No.9 in turn conspired with accused No.1 and 3 and thereby you accused committed an offence punishable under Section 120B r/w. Sec 302 of I.P.C. and within the cognizance of court of session.

Secondly, that you accused Nos.1, 2, 5 to 7, 10 to 13 in furtherance of common object of your unlawful assembly on 23.10.2020 at 6.30 p.m. abducted deceased from a temple on Sulibele road in Hosakote Town in Tata Ace Goods vehicle bearing KA-53-D-5381 of you accused no.6, the presence of deceased at that place you accused Nos.1 and 3 procured through C.W.23 and you accused no.4 joined the said accused in the vehicle of accused no.6 at Bidarahalli circle and took the deceased to the old house of you accused No.8 in Saraswathi Nagar at Mahadevapura at the direction of you accused Nos.8 and 9 within the limits of Channarayapatna police station knowing that the deceased belongs to Schedule community and you accused no.4, 5, 8, 10 to 13 not belonging to either Schedule Caste or Schedule Tribe and thereby committed an offence punishable under Section 364 r/w.Sec.149 of I.P.C. and you accused no.4, 5, 8, 10 to 13 further committed the offence punishable u/Sec 3(2)(v) of SC/ST (POA) Act of 1989 and within the cognizance of court of session.

Thirdly, that between the time from the night on 23.10.2020 and afternoon on 24.10.2020 in the house of you accused no.8 stated above you accused no.1, 2, 5 to 13 with intent to cause deceased to be secretly and wrongfully confined and thereby committed an offence punishable under Section 365 r/w.Sec.149 of I.P.C. and you accused no.4, 5, 8, 10 to 13 further committed the offence punishable u/Sec 3(2)(va) of SC/ST (POA) Act of 1989 and within the cognizance of court of session.

Fourthly, that between the time from the night on 23.10.2020 and afternoon on 24.10.2020 in the house of you accused no.8 stated above you accused no.1 to 7, 9 to 13 in prosecution of your common object committed murder of deceased Girish to wit: assaulted deceased with hands, with sticks, cord and kicked him and in the process the deceased even got hurt to his head from the bolt fastened to cot lying in the said house and who died as a result of injuries so caused by you at 5.30 p.m. on 24.10.2020 and thereby you accused no.1 to 7, 9 to 13 committed offence punishable under Section 302 r/w.Sec.149 of I.P.C. and you accused no.8 shared common object with aforesaid accused and thereby committed offence punishable u/Sec 302 r/w 149 of IPC and you accused no.4, 5, 8, 10 to 13 further committed the offence punishable u/Sec 3(2)(v) of SC/ST (POA) Act of 1989 and within the cognizance of court of session.

Lastly, that you above named accused no.1, 3, 4, 8, 9, 11 and 12 knowing that offence punishable with death or imprisonment for life has been committed with intention of

screening yourselves from legal punishment caused evidence of commission of that offence to disappear to wit: you accused covered the dead body in a bed sheet and on 24.10.2020 at 10 p.m. shifted the dead body from the house of you accused no.8 in Mahadevapura and disposed it of near Budigere Tank and you accused no.1 disposed of the cord used in assaulting deceased, the stained cloths of deceased in a big drain near Bidarahalli and damaged mobile phone of deceased near whitefield railway track and mobile phones of CW.23 mamatha and of accused no.2 into the Bande Bommasandra Tank and thereby committed an offence punishable under Section 201 r/w.Sec.149 of I.P.C. and within the cognizance of court of session.

And I hereby direct that you be tried before me on the said charge.
