2 made propaganda in respect of fact of your second marriage, did an act of piercing CW-2 at his abdomen by using knife with such intention or knowledge and under the circumstances that, if by that act you had caused the death of said CW-2, you would have been guilty of culpable homicide not amounting to murder and thereby committed an offence punishable U/s.109 of BNS within the cognizance of this court.

And, I hereby direct that you shall be tried by this Court for the above said charge.
