CHARGE

I, J.V VIJAYANANDA, IX Additional District & Sessions Judge, Bengaluru Rural District, Bengaluru, do hereby charge above accused as follows:

2. That on 16-02-2020 in between 03:00p.m, to 11:00p.m., in open place, Mudhinapalya Main Road, Anjananagar, Bengaluru city within the limits of complainant police station, you A1 to A5 were a member of an unlawful assembly, the common object was which to murder Prasanna Kumar and thereby committed an offence punishable U/s. 143 of Indian Penal Code.

3. That on the above said date, time and place, you A1 to A5 were a member of an unlawful assembly and in prosecution of the common object of said assembly was to murder Prasanna Kumar, committed an offence of rioting and thereby committed an offence punishable U/s. 147 of Indian Penal Code.

4. That on the above said date, time and place, you A1 to A5 were a member of an unlawful assembly and were at the time armed with a deadly weapons like clubs and thereby committed an offence punishable U/s. 148 of Indian Penal Code.

5. That on the above said date, time and place, you A1 to A5 in furtherance of common object, wrongfully confined CW.1, 2 and deceased Prasanna Kumar and there by committed an offence punishable U/s. 342 R/w. Sec. 149 of Indian Penal Code

6. That on the above said date, time and place, you A1 to A5 in furtherance of common object, kidnapped CW.1 and 2 and deceased Prasanna Kumar for ransom and confined them in a newly constructing building at Mudhinapalya Main Road and threatened to cause death and demanded money of Rs.15,000/- and there by committed an offence punishable U/s. 364(a) of Indian Penal Code.

7. That on the above said date, time and place, you A1 to A5 in furtherance of common object, committed murder intentionally causing death of Prasanna Kumar and there by committed an offence punishable U/s. 302 R/w. Sec.149 of Indian Penal Code.

8. And I hereby direct that you be tried by this court on the above said charge.
