EXAMINATION-IN-CHIEF BY LEARNED P.P:

I do not know the accused persons who are present before the court today. My husband died in the year 2018. I do not know how my husband died. I do not know who have murdered my husband in the year 2018. In the year 2018 I have lodged a missing complaint of my husband. After laps of 3 days of lodging a complaint, the Kaggalipura police informed me about found of dead body of my husband in the R.R.Hospital. I went to R.R.Hospital and found my husband dead body. I could

not find the injuries found on the dead body of my husband. The police have not recorded my statement at R.R.Hospital. So far, I have not received any information about murder of my husband. The missing complaint given by me is marked as Ex.P.1, Ex.P.1(a) is my signature.

(At this stage the learned PP sought permission to treat the witness as hostile. Heard, perused the statement of witness. Since the witness has not deposed as per the statement, permission is granted to treat this witness as hostile.)

CROSS-EXAMINATION BY LEARNED P.P:

On 31-08-2018 my husband left the house to a bricks factory at 06:00am itself. On that day even till late night he did not returned to home. It is true that on the next day I went to the bricks factory where my husband was working and enquired one Mahadev about missing of my husband. It is false to suggest that on 31-08-2018 at about 01:30pm two persons came near the factory and enquired about my husband and then my husband has

left the factory along with those two persons in the motor cycle. It is not true that on 01-09-2018 I lodged a complaint before the police. It is false to suggest that the accused persons have murdered my husband and the same was intimated by the police to me. It is true that my father and myself went to R.R.Hospital to look after my deceased husband. It is false to suggest that I came to know through the police that all the accused persons have murdered my husband. It is false to suggest that accused persons have murdered my husband at Doddakadu place and assaulted with chopper and size stone and after the murder he was tied with gunny bag and thrown out and also the dead body was carried in the All car and thrown the dead body to the Rushabhavathi River. It is false to suggest that I have given a re statement before the police as per Ex.P.2 like 31-08-2018
