Suit claim: Suit was filed on **21/03/2024** by the plaintiff and prays to pass a Judgment and Decree against the defendants as follows :

A) Directing the Defendants to pay of Rs.5,47,98,127/- (Rupees Five crore forty seven lakhs ninety eight thousand one hundred and twenty seven only) for the purpose of jurisdiction and payment of court and return of bank guarantee claimed under claim No.7 and towards the amount of claims settled by this Honourable Court to the plaintiff for the work. Formation of C.C.Rod FROM Fly Ash Silo to proposed gate-4 at YTPS” the work was awarded under Contract Agreement – No.EEC4/Ten-Agr/02/2019-20/31 Dated : 29-04-2019” or such other amount as ascertained by the Court after adjudication of claims.

(B) That to award interest @18% per annum on the decretal amount of claims awarded to the plaintiff from the date of filing the commercial suit till realization.

(C) That to award costs of the suit to the plaintiff; and

(D) That to grant such other relief/s in favour of the plaintiff.

This suit coming on this day for final disposal before **SRI. JITHENDRANATH. C. S, LXXXVI Additional City Civil & Sessions Judge, Commercial Court, Bangalore**, in the presence of Sri. P. Harischandra Reddy, Advocate for the Plaintiff; Sri. Goutham. K. V and Sri. Vivek. S, Advocate for the Defendants.

It is ordered and decreed that the suit of the plaintiff is hereby partly decreed with proportionate costs.

It is further ordered and decreed that the defendants do pay a sum of Rs.84,645/- (Rupees Eighty Four

Thousand Six Hundred and Forty Five only) to the plaintiff along with interest at the rate of 18% p.a. from the date of deduction of penalty till its realization.

It is further ordered and decreed that Rest of the claims are hereby dismissed.

And that a sum of **Rs.16,807/-** to be paid by the Defendants to the Plaintiff on account of the costs of this suit.
