**This common order shall deal with the applications filed
U/s. 439 CrPC on behalf of applicants/accused Manoj Kumar, Kishan
Lal and Bunty for grant of bail.**

Victim Happy in person.

IO SI Naresh Kumar is present and files reply to the bail
applications. Reply perused.

Arguments heard on bail applications from both sides.

As per facts reported by the IO, victim Happy had a love
affair with Ms. Shalu, who is real sister of accused Raju and Bunty,
daughter of accused Kishan Lal and cousin sister of accused Manoj Kumar.
The accused persons were against the relationship of victim Happy with
Shalu and advised the victim to stay away from Happy.

On 29/06/2020, accused Raju stabbed victim Happy in his
abdomen with knife. Applicant/accused Bunty, Kishan Lal and Manoj
joined Raju in beating victim Happy at the spot.

However, the accused persons voluntarily agreed to marriage of Shalu with victim Happy, which was solemnized in July, 2020. Victim Happy states that now his injury has healed and he has no complaint against the applicants/accused persons.

The accused persons are in judicial custody since 04/11/2020. It seems that there is no threat to life and safety of victim Happy from the applicants/accused persons as they have settled the matter with him and married their sister/daughter Shalu with the victim. Co-accused Raju, who stabbed victim Happy has already been granted bail.

In view of facts and circumstances of the case, the bail applications are allowed. Applicants/accused Manoj Kumar, Kishan Lal and Bunty are admitted to bail subject to furnishing personal bonds of Rs.20,000/- each with one surety of like amount each to the satisfaction of Ld. MM/Ld. Duty MM.

The bail applications are disposed of accordingly.
