ORDER

1. Through this application, applicant has applied and prayed for seeking direction to Superintendent, District Jail: Amphalla, Jammu for providing necessary treatment to the applicant stating that the applicant is under trial in case mentioned above. The applicant is suffering from many diseases and for the last about 10 days is suffering from acute and sharp pain in his throat and resultantly he is unable to swallow food and drinks. Despite repeated request to jail authorities for ENT Specialist consultant no effective medical intervention has been provided to the applicant, therefore to safe guard the life and health of the applicant. Jail authorities be directed to refer the applicant to specialised hospital for treatment of his throat related ailment.
2. On presentation of this application on 24.06.2026, report was called from Superintendent District Jail, Amphalla as to the contents of this application, report received i.e. on 27.06.2026, in which it is submitted by the Sr. Medical Officer District Jail, Amphalla, Jammu that:

“inmate is known case of hypertension, T2 DM, solitary kidney atrial fibrillation (A/F) sinus node disease with post PPIC (Permanent Pacemaker implant) Glaucoma; past H/O urethral stricture. He is under routine treatment and follow up as being done from consultant from GMCH and SSH from consultant of cardiologist, surgery endocrinologist, urologist, ophthalmologist and dermatologist urology consultation was done on 11.05.2026 and after examination consultant has advised to C.S.T, surgical consultation was given on 18.05.2026 and after examination he has advised medicine, which has been provided to him and advise USG abdomen, which was done and report reveal “simple cortical cyst in right kidney; left kidney not visualised; Grade-I prostatic hypertrophy; splenic cyst gastroenterology consultant was given on 08.06.2026 and after examination he was prescribed some medicine, which was given to him.”

3. Heard and perused as per the application applicant is found genuinely sick having throat pain and as per the report applicant was given ENT consultation on 25.06.2026 on examination consultant has diagnosed laryngopharyngeal reflux and prescribed medicine for the same.
4. Therefore, this application is well founded as per the report of doctor, same is disposed of with further direction to the Superintendent, District Jail: Amphalla to get the applicant further medically consulted and treated from specialised doctor for his throat pain on need basis and submit the final examination report within 15 days time.
5. Copy of this order be sent to Superintendent, District Jail: Amphalla for compliance through Spl. PP SIA, Jammu. This application requires no further proceedings, same is disposed of and file be made part of the main case-file.
