ORDER

1. Earlier interim anticipatory bail was granted to the
accused/applicant Harmeet Kaur and on 01.05.2018, ASI
Balbir Singh, No. 86/TT has appeared in the court and
stated that in the present case bearing FIR no. 69 Dated
02.04.2018 u/s 295/353/186/506/148/149 IPC, PS Sadar
Tarn Taran, FIR has been registered against the five accused
by name and in which accused namely Sukhjinder singh s/o
Nirmal singh, Manpreet singh @ mannu s/o Nirmal singh,
Sarwan singh s/o Jagir singh, Dharminder singh s/o Sarwan
singh, Harmeet kaur w/o Sukhjinder singh All R/o Vill. Kambo,

PS Sadar, Tarn Taran have joined the investigation on 28.04.2018, as per the orders of this Hon'ble court dated 12.04.2018. The present case has been registered on the complaint of Sh. Kulwant singh Nambardar R/o Village Kambo, Distt. Tarn Taran. No any injury has been attributed to the complainant by all the accused. Now nothing is yet to be recovered from the accused and they are not required for further investigation.

2. As such keeping in view these facts of the case and totality of the facts of the present case and without commenting upon the merits of the case, this court is of the opinion that no custodial interrogation of the accused- **Harmeet Kaur** is required and she is hereby granted the concession of anticipatory bail and S/he/they is/are ordered to be released on bail in case of her/his/their arrest on his/her furnishing bails bonds to the satisfaction of the concerned court/arresting officer subject to the following conditions:

(a) That, the accused-applicant(s) will appear before the IO and join the investigation as and when required by the IO in accordance with law.

(b) That, S/he/they will not leave the country without prior permission of the concerned Court.

(c) That, S/he/they will neither tamper with the evidence nor induce or threat the prosecution witnesses.
