This case came before me on this day for final hearing in the presence of the learned A.P.P on behalf of the state and of Sri E.Lakshminarayana, learned counsel for the Accused, and after hearing both sides, and having stood over for determination till this day, this Court passed the following:

O R D E R

1. The Sub-Inspector of Police, Challapalli P.S., has filed the Charge sheet against the accused for the offence punishable U/s . 302 of IPC.
2. Cognizance of the offence punishable U/s . 302 of IPC was taken against the accused. Summons were issued to the accused. On appearance of the accused, Copies of documents were furnished to her as required u/s 207 Cr.P.C.
3. On perusal of Case records, it appears that the case is exclusively triable by the Honourable Court of Sessions Division, Machilipatnam. Hence

I commit the Case to the Hon'ble Court of District and Sessions Judge, Krishna at Machilipatnam u/s 209 (a) Cr.P.C.

4. The accused was remanded to judicial custody on 30-07-2022, and she was released on bail on 19-11-2022 as per the orders of the Hon'ble Sessions Judge, Krishna at Machilipatnam in CrI.M.P.No.254/2022 dated 17-11-2022. The accused was ordered to be continued on bail, and on such terms and conditions as imposed at the time of granting of bail to her as per the provision u/s.209(b) Cr.P.C.

5. The entire Case records and property, if any, are ordered to be submitted to the Honourable Court of District and Sessions Judge, Krishna at Machilipatnam u/Sec.209 (c) Cr.P.C.

6. Notify the Learned Public Prosecutor about the commitment of this Case to the Honourable Court of District and Sessions Judge, Krishna at Machilipatnam u/Sec. 209(d) Cr.P.C.

7. When the accused was asked about her means to engage a Counsel on her behalf to defend her in the case before the Hon'ble Sessions Court, she stated that she has means to engage a counsel at the Honourable Court of District and Sessions Judge, Krishna at Machilipatnam.
