EVIDENCE OF PLAINTIFF BY WAY OF AFFIDAVIT
(SPA HOLDER OF PLAINTIFF)

I, K.M. Narayanaswamy, S/o R. Muniswamigowda, aged about 44 years, residing at Karadabande Hosahalli Village, Narasapura Hobli, Kolar Taluk and District, presently on a visit to Bengaluru, being the Special Power of Attorney Holder of the plaintiff, do hereby solemnly affirm and state on oath as follows:

1. I state that I am the Special Power of Attorney Holder of the plaintiff in the above case. I am well acquainted with the facts and circumstances of the case, and the plaintiff has authorized me to depose on her behalf and swear to this affidavit. Hence, I am competent to tender this affidavit in lieu of examination in chief.
2. I state that the plaintiff is the absolute owner and in peaceful possession and enjoyment of the agricultural land bearing Sy. No. 3, measuring an extent of 3 Acres 29 Guntas, situated at Huskur Village, Bidarahalli Hobli, Bengaluru East Taluk, which is more fully described in the schedule to the plaint (hereinafter referred to as the "suit schedule property").
3. I state that the plaintiff acquired title to the suit schedule property through Pavathi Varasu Khatha, being the sole legal heir of late Doddakempaiah, vide IHC No. 29/1986-87. Consequent the RTC came to be effected in the name of the plaintiff.

8. I state that immediately thereafter, the plaintiff lodged a complaint before the jurisdictional police, which was received and registered as GSC No. P01916210600806, dated 11.11.2021, as a Non-Cognizable Report. Though the complaint specifically disclosed offences relating to criminal trespass, assault and criminal intimidation, no FIR has been registered against the defendants till this day. This clearly indicates that the defendants have exercised undue influence over the jurisdictional police authorities.
9. I state that the defendants are influential persons in the locality, having the support of muscle power and other resources. Taking undue advantage of the plaintiff's old age, helplessness and lack of support, as well as that of her daughter, the defendants are repeatedly interfering with the plaintiff's peaceful possession and cultivation of the suit schedule property.
10. I state that the continuous illegal interference by the defendants with the plaintiff's peaceful possession, enjoyment and cultivation of the suit schedule property has caused immense hardship and inconvenience to the plaintiff and her family members. Unless the defendants are restrained by an order of this Hon'ble Court, the plaintiff will suffer irreparable loss and injury, which cannot be adequately compensated in terms of money, and the same will result in multiplicity of legal proceedings.

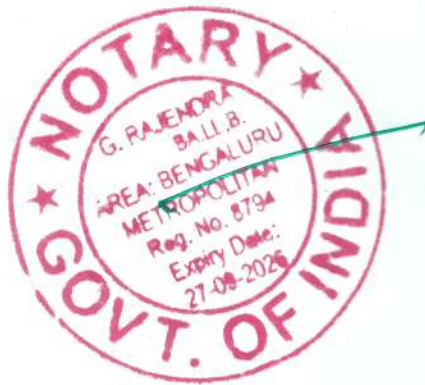
