ORDER

This is a private complaint filed by the complainant ie The RFO, Holalkere Range, Holalkere has filed a private complaint U/Sec.200 of Cr. P. C., against the accused No.1 to 6 for the offence punishable under section 9, 39, 40, 48A, 49B, 50, 51 and 55 of Wild Life (Protection) Act, 1972, Schedule-I of the 1972 Act vide Sl.No.28 and 2 of Part-I, 71(a) of Karanataka Forest Act-1963 and Sec.8 and 20 of Arms Act-1959.

2. On the basis of the averments of the complaint and the documents produced by the complainant this court has took cognizance of the above said offences. Since the complainant is a public servant and he has filed the aforesaid case against the accused in the discharge of his official duties and hence recording of sworn statement is dispensed with as per section 200 (a) of Cr. P. C.

3. I have perused the complainant and the material placed on record. There is a prima-facie case against the accused to proceed with the case, at this stage of the proceedings this court need not weigh the evidence meticulously and it need not go into the aspect as to where the accused had sufficient information and material against the complainant, the said question are to be determined at the stage of trial, therefore, on a cursory perusal on the complaint and the material place on record there appears a cognizable case against the accused, hence I am of the opinion that there are sufficient ground to proceed against the accused.

4. On going through the complaint averments and circumstances of the case is appears to this court that the nature of the case. On scrutinizing the complaint and the documents produced before me, I found sufficient materials to proceed against the accused persons for the offences punishable under section 9, 39, 40, 48A, 49B, 50, 51 and 55 of Wild Life (Protection) Act, 1972,

Schedule-I of the 1972 Act vide Sl.No.28 and 2 of Part-I, 71(a) of Karanataka Forest Act-1963 and Sec.8 and 20 of Arms Act-1959. In the result I proceed to pass the following order:

Office is directed to register this case as criminal case in III register (Criminal) against the accused person for the offences punishable under sections under section 9, 39, 40, 48A, 49B, 50, 51 and 55 of Wild Life (Protection) Act,1972, Schedule-I of the 1972 Act vide Sl.No.28 and 2 of Part-I, 71(a) of Karanataka Forest Act-1963 and Sec.8 and 20 of Arms Act-1959.
