It is incorrect that I had made

wrong entry in the special report register. It is correct that I had not mentioned time in Ext.P2/PW-7. It is incorrect that I am deposing falsely.

I came by bus and I handed over the special report at about 11:27 am to ASP Abishek S. It is incorrect that I had not handed over the special report to ASP Abishek S. on 10.08.2022. The report was inside the envelope. It is correct that I do not know the contents of the report. It is correct that the office of ASP Abishek S. is at S.P. Office Shimla. Self stated on the said date he was present at P.S. Boileauganj in relation to some work. It is correct that I was asked to deliver the special report to ASP Abishek S. at his office situated at S.P. office Shimla. Self stated he was present at P.S. Boileauganj so I delivered the report at P.S. Boileauganj. It is correct that police station Boileauganj is situated at a place which is

separate from the main road approach from P.P. Shoghi to S.P. Office Shimla. It is correct that all the buses from PP Shoghi directly goes to bus stand Shimla and none of the bus comes towards Boileauganj. It is correct that I had not received any message to the effect that ASP Abishek S. would be present at P.S. Boileauganj on 10.08.2022. self stated before leaving PP Shoghi, we had called the reader to ASP so as to confirm that ASP was present in his office and he told us that ASP Abishek S. will be present at P.S. Boileauganj. I had called the reader on that day on telephone. I do not remember where ASP Abishek S. was sitting on 10.08.2022 at police station Boileauganj. It is incorrect that I had not handed over the special report to ASP Additional S.P. Shimla. It is incorrect that I am deposing falsely.

It is correct that the contents of the parcel were not weighed in my presence nor the parcel was weighed at the time when I handed over the parcel to SFSL Incharge. It is incorrect that the contents of the parcel were tampered in my custody. It is incorrect that I had not handed over the parcel to SFSL Junga. It is

incorrect that I am deposing falsely.

The seal impression was not embossed on the parcel in my presence nor the seal was shown to me. It is correct that I was not aware about the contents of the parcel and about the report when these were handed over to me. The report as well as the case property was handed over by me to MHC Boileauganj at about 6:30-7:00 pm. It is incorrect that the parcel was tampered when it remained in my possession. It is incorrect that I am deposing falsely.
