

Perused the plaint, documents produced along with plaint, I.A No.1 and affidavit annexed to the IA No.1. The suit properties are standing in the name of defendant No. 1 and 4. Considering the contentions of materials on record at this stage this court is of the opinion that the plaintiffs have made out a prima facie case.

If notice on I.A No.1 is ordered to be issued to the defendants, the very purpose of filing the suit and granting TI on a later date will be defeated, if the defendants succeeded in their attempt, then the plaintiffs will be put to great hardship. Therefore, to meet the ends of justice I proceed to pass the following.

ORDER

The defendants are hereby temporarily restrained from alienating the suit schedule properties in any manner till next date of hearing.

Plaintiff shall comply order 39 Rule 3 of CPC.

Issue suit summons and emergent notice on I.A.No.1 to the defendants and TI order if PF paid and after compliance.
