CHARGE.

I, Sri Ron Vasudev, B.Com, LL.B(Spl), Prl. District & Sessions Judge, Chitradurga, hereby charge you accused viz.

1. Teja S/o Prudhviraaju.A,
aged about 29 years,
2. Somasekhara
S/o Mangala Ramanjineyulu,
aged about 36 years,
3. Dropped
4. Radhamma W/o Ramajineyulu,
aged about 46 years,
5. Ramanjineyulu S/o Late Obanna P.
aged about 52 years,
6. Veerasha N S/o Nagappa,
aged about 33 years,
R/o Rampura Village, Chikkahalli Post,
Y.N.Hosakote, Pavagada Taluk,
Tumakur District.

Accused No.1, 2, 4 and 5 are
R/o Yatakallu Village, Settur Post,
Anantapur, Andhra Pradesh.

as follows:

1. Firstly, that you accused No.1, 2, 4 to 6 being members of unlawful assembly in prosecution of common object of such assembly on 05.11.2021 in Y.N.Hosakote police station when

Maruthi and already married Indu were traced by the police and were brought to the said police station, threatened Maruthi not to continue his illicit relationship with her and thereby committed an offence punishable U/S.143 r/w/s 149 of IPC and within my cognizance.

2. Secondly that you accused No.1, 2, 4 to 6 on the above said date, time and place being members of unlawful assembly in prosecution of common object of such assembly by abusing and insulting Maruthi in vulgar language so as to provoke him for breach of peace thereby committed an offence punishable U/S.504 r/w/s 149 of IPC and within my cognizance.
3. Thirdly that you accused No.1, 2, 4 to 6 on the above said date, time and place being members of unlawful assembly in prosecution of common object of such assembly by threatening Maruthi to kill him if he continues his illicit relationship with said Indu thereby committed an offence punishable U/S.506 r/w/s 149 of IPC and within my cognizance.
4. Fourthly that you accused No.1, 2, 4 to 6 on the above said date, time and place being members of unlawful assembly in prosecution of common object of such assembly by threatening Maruthi to kill him if he continues his illicit relationship with said Indu and asking him to go and die, abetted him to commit suicide and as a result of such abetment, between 7.11.2021 and 19.1.2022 he committed suicide by hanging himself in a dilapidated quarters of sugar factory, situating adjoining to ITI college, Hiriyuru and

thereby committed an offence punishable U/S.306 r/w/s 149 of IPC and within my cognizance.

And I hereby direct that you be tried on the above said charge.
