

**IN THE COURT OF THE PRINCIPAL DISTRICT AND
SESSIONS JUDGE, AT CHITRADURGA.**

SC 97/2023.

Complainant State by Hosadurga police.

/versus/

Accused: Raja and others.

CHARGE.

I, Sri Ron Vasudev, B.Com, LL.B(Spl), Prl. District
& Sessions Judge, Chitradurga, hereby charge you accused
viz.

1. Raja s/o Siddappa, aged about 45 years,
Proff: agriculturist,
R/o Menasinahalli Gollarahatty village,
Hosadurga taluk, Chitradurga district
 2. Usha d/o Rajappa, aged about 22 years,
Native of Lakkayyanapalya
Present r/o Menasinahalli Gollarahatty village,
Hosadurga taluk, Chitradurga district
 3. Mallamma w/o Siddappa, aged about 60 years,
R/o Menasinahalli Gollarahatty village,
Hosadurga taluk, Chitradurga district
- as follows:

1. Firstly, that you accused No.1 to 3 with a common
intention on 7.11.2022 at about 4.30 p.m., when CW.1/
Basavaraja was standing beside Merchants petrol bank
on Hiriyuru road, Hosadurga town, Opp. to “Namma
Adda” hotel, on the reason that the said CW.1 did not
support you in the village panchayath abused him in
vulgar language so as to provoke him for breach of
peace and thereby committed an offence punishable
under section 504 r/w/s 34 of IPC and within my
cognizance.

2. Secondly, on the above said date, time and place with a common intention, you accused No.1 to 3 by beating and kicking CW.1 with hands and legs all over his body caused simple injuries to him and thereby committed an offence punishable under section 323 r/w/s 34 of IPC and within my cognizance.
3. Thirdly, on the above said date, time and place with a common intention, you accused No.1 and 2 by hitting CW.1 with your slippers intentionally dishonoured him without any provocation on his part and thereby committed an offence punishable under section 355 r/w/s 34 of IPC and within my cognizance.
4. Fourthly, on the said date, time and place with a common intention you accused No.1 by using a blade tried to kill CW.1 by attempting to cut his neck and in the process caused bleeding injuries to his left eye and stomach when he tried to save himself and thereby committed an offence punishable under section 307 r/w/s 34 IPC and within my cognizance.
5. Fifthly, that you accused No.1 to 3 on the above said date, time and place with a common intention by threatening the CW.1 to finish him and thereby committed an offence punishable under section 506 r/w/s 34 of IPC and within my cognizance.

And I hereby direct that you be tried on the above said charges.
