Accused Manjeet on bail, not present whereas accused Gaurav @ Bhagta on bail with Sh. Vinay Kumar Tanwar, Advocate.
Accused Udaybhan on bail in this case but in custody in some other case represented by Sh. Vinay Kumar Tanwar, Advocate.
Accused Vikas Bhatti on bail in this case but in custody in some other case, not produced represented by Ms. Krishna Chauhan, Advocate.
Accused Sunnypal @ Lucky on bail in this case but in custody in some other case represented by Sh. Vinay Tanwar, Advocate.

An application for exemption from personal appearance of the accused Manjeet has been moved. Heard. Keeping in view of the averments mentioned in the application, the same stands allowed, for today only.

Accused Udaybhan, Sunnypal @ Lucky and Ujjwal produced before the Court in custody through VC.

Accused Vikas Bhatti not produced before me by the concerned jail authorities. Production warrants against accused Vikas Bhatti not issued. Let, his production warrants be issued in the name of Superintendent District Jail, Bhiwani for **08.01.2027** with a direction to produce the accused before the Court for the date fixed. **A red ink note on the production warrant be given that accused Vikas Bhatti is on bail in this case.**

Today the present case is fixed for evidence of the prosecution. No prosecution witness is present. Non-bailable warrants to PWs namely Sombir @ Sonu and Ashok not issued. Let, the said witnesses be summoned through non-bailable warrants for the date fixed.

Bailable warrants to PWs Radiologist Dr. Jatinderpal Singh, ASI Dharm Singh and Dr. Dasrath Rao MO GH, Bhiwani also not issued. Let, the said witnesses be summoned through bailable warrants in the sum of Rs. 5,000/- with one surety in the like amount each for the date fixed. All the remaining unexamined witnesses be also summoned for the date fixed.

Accused **Sunnypal @ Lucky, Ujjwal and Udyabhan** be also produced before the Court, if they remains in custody in some other case for the date fixed.
