

Accused No.1, 2 & 4 are present.

Sri B.S.K., Advocate, files vakalath for accused No.1, 2 & 4.

Accused No.1, 2 & 4 submit that they are intending to plead guilty. The substance of accusation is read over to the accused in the language known to them. Accused No.1 pleads guilty for the offence punishable under Section 281, 125(a), 125(b) of B.N.S. and Sec.181 and 196 of I.M.V. Act. Accused No.2 pleads guilty for the offence punishable under Section 180 and 196 of I.M.V. Act. Accused No.3 pleads guilty for the offence punishable under Section 181 and 196 of I.M.V. Act. Pleading of guilt by the accused appears to have been made voluntarily. Considering the nature of offence and keeping in mind, principle of criminal justice and considering the submission of accused, this court proceeds to pass the following:

ORDER

Under the powers conferred upon this Court under section 275 of B.N.S.S. the accused No.1 is convicted for the offences punishable under section 281, 125(a), 125(b) of B.N.S. and Sec.181 and 196 of I.M.V. Act, the accused No.2 is convicted for the offences punishable under section 180 and 196 of I.M.V. Act, the accused No.4 is convicted for the offences punishable under section 181 and 196 of I.M.V. Act.

For the offence punishable under section 281 of B.N.S., the accused No.1 is sentenced to pay

fine amount of Rs.1,000/-. In default he shall undergo SI for a period of 10 days.

For the offence punishable under section 125(a) of B.N.S., the accused No.1 is sentenced to pay fine amount of Rs.3,000/-. In default he shall undergo SI for a period of one month.

For the offence punishable under section 125(b) of B.N.S., the accused No.1 is sentenced to pay fine amount of Rs.5,000/-. In default he shall undergo SI for a period of one month.

For the offence punishable under section 181 of I.M.V. Act, the accused No.1 is sentenced to pay fine amount of Rs.1,000/-. In default he shall undergo SI for a period of 10 days.

For the offence punishable under section 196 of I.M.V. Act, the accused No.1 is sentenced to pay fine amount of Rs.1,000/-. In default he shall undergo SI for a period of 10 days.

For the offence punishable under section 180 of I.M.V. Act, the accused No.2 is sentenced to pay fine amount of Rs.1,000/-. In default he shall undergo SI for a period of 10 days.

For the offence punishable under section 196 of I.M.V. Act, the accused No.2 is sentenced to pay fine amount of Rs.1,000/-. In default he shall undergo SI for a period of 10 days.

For the offence punishable under section 181 of I.M.V. Act, the accused No.4 is sentenced to pay fine amount of Rs.1,000/-. In default he shall undergo SI for a period of 10 days.

For the offence punishable under section 196 of I.M.V. Act, the accused No.4 is sentenced to

pay fine amount of Rs.1,000/-. In default he shall undergo SI for a period of 10 days.
