ORDERS ON BAIL APPLICATION

Counsel for the accused No.1 to 6 have filed bail application U/Sec.480 of BNSS along with surety affidavit and submits that, accused is law abiding person and they are not committed the alleged offence and they have granted anticipatory bail by the Hon'ble Prl. District and Sessions Court, Chitradurga in Crl.Misc No.381/2025 dated 21.02.2025 and they are ready to abide all the conditions imposed by this court. Hence, prayed to allow the application.

2. Per contra, learned APP has orally objected on bail, as such prayed to reject the bail application.

3. Heard and perused the entire record. I have considered the above application the alleged O/P/U/Sec. 115(2), 118(1),

191(2), 191(3), 351(2), 352, 74 R/w 190 of BNS.

4. The Hon'ble Prl. District court, Chitradurga has allowed the petition filed by the accused U/Sec.483(1)(b) of BNSS and enlarged accused on bail.

In view of the decision reported in *2010 (8) Supreme Court, page 353; 2011(1) SCC, page 694 (Siddharam Satlingappa Mhetre Vs. State of MH)*, the anticipatory bail shall be in force till the conclusion of trial and hence, no separate bail order needs to be passed by this Court. In view of the anticipatory bail, application filed by the accused No.1 to 6 is hereby allowed. Hence, on the very same terms and conditions it is sufficient to allow the present application and take bonds.

ORDER

The bail application filed by the accused No.1 to 6 U/Sec.480 of BNSS is allowed. Thereby, accused persons are ordered to be release on bail on execution of personal bond for Rs.50,000/- with a surety for the likesum.

The accused No.1 to 6 shall follow the following:

CONDITIONS:

1. The accused No.1 to 6 shall not involve in the any criminal activity henceforth.
2. The accused No.1 to 6 shall co-operate with investigation officer and shall appear before him as and when directed.
3. The accused No.1 to 6 shall not threaten the prosecution witnesses nor tamper the prosecution evidence.

Surety by name Sri.G.Yogesh K. S/o. Kariyappa, Aged about 40 years, agriculturist, R/o.Paramenahally Village, Kasaba Hobli Hiriyur Taluk, Chitradurga District is present and filed his surety affidavit with declaration and documents such as RTC extract bearing Sy.No.207/2 measuring 2 acres situated at Paramenahally Village, Kasaba Hobli Hiriyur Taluk, and copy of Aadhaar Card offering himself as surety for accused persons. Thereby surety is satisfied and surety ship is accepted.
