ORDER.

Kulwinder Kaur and Harpreet Singh (applicants/accused)

have filed instant bail application under **Section 482 of B.N.S.S.** for

grant of anticipatory bail, in the above noted case, on the grounds of false implication.

2. Vide Order dated **23.06.2026**, applicants/accused were granted interim anticipatory bail to join the investigation within four days.

3. I have heard rival submissions put forth by learned counsel for the parties, and have gone through record with their able assistance.

4. **Learned Addl.PP for the State** has vehemently opposed the bail application and submitted that, since applicants/accused committed serious offence, therefore, opposed prayer.

5. ***Assistant Sub Inspector Sukhpal Singh No.1544/FZR, Police Station Mallanwala, District Ferozepur***, has appeared and submitted statement that applicants/accused have joined the investigation of this case on 24.06.2026, in pursuance of order dated 23.06.2026 and they are no more required for the purpose of further investigation.

6. From above discussion, it transpires that **Kulwinder Kaur and Harpreet Singh (applicants/accused)** have already joined the investigation, in pursuance of order dated **23.06.2026**, so the interim bail order ***dated 23.06.2026*** stands ***confirmed and made absolute***, subject to the following conditions :-

1. That the applicants-accused will not tamper with the prosecution evidence in any manner.
2. That the applicants-accused will not leave the limits of India without prior permission of the court.
3. That the applicants-accused will attend the court on each and every date.

However, these observation of mine shall have no effect on the merits of the case. File be consigned to record room.
