PRAYER:-

The plaintiff respectfully prayed that this Hon'ble court
may kindly be pleased to pass Judgment and Decree in favour

of plaintiff and against the defendants for the following reliefs.

a. Directing the defendant No.1 to effect partition of the suit schedule property by metes and bounds and put the plaintiff in actual and physical possession of his legal and legitimate share over the suit schedule property.

b. Restraining the defendant No.1 & 2 their Agents, P.A Holders, servants, henchmen or any other person or persons claiming any right or rights in any manner whatsoever through or under them from alienating, transferring or encumbering the suit schedule properties in any manner either by way of sale, mortgage, exchange etc., either by themselves or through his servants, henchman, agents, power of attorney holders or any other person or persons claiming any right or rights in any manner whatsoever under or through him either among them or in favour of third parties by granting permanent injunction.

c. Directing the defendants No.1 & 2 to hold enquiry for menses profits under Order XX Rule 21 of the code of civil procedure,

d. Granting cost of the suit and any other relief/s as this Hon'ble court deem fit under the circumstances of the case in the interest of justice and equity.

e. To allot the share of defendant No.1 N.Narasimmappa's 1/6th share in favour of plaintiff as per the registered will dated 27-08-2018 in the interest of justice."
