This complaint has been filed by a public servant Sh. Sachin Kumar, IO in discharge of his duties. He has moved an application for dispensing with his preliminary examination and for his exemption from personal appearance for future dates on the ground that he remains busy in official duties and it is not possible for him to attend the court on each and every date of hearing and that he be therefore allowed to be represented through the Special PP. In view of the submissions made, the preliminary examination of the complainant is dispensed with and he is exempted from personal appearance during trial

Perused the complaint.

Brief facts of the case are that on 27.06.2024 on the basis of secret information 11 parcels containing 66.75gm of methamphetamine were recovered as same were booked by

accused Mohd. Nadeem @ Rohit, thereafter on the disclosure of accused Mohd. Nadeem, accused Egenti was apprehended with 86gm of methamphetamine and out of 11 parcels, Venkta Reddy K and Prateek Goel were receivers of the one parcel each, from the parcel in name of accused Venkata Reddy 10.50gm of methamphetamine was recovered while from parcel in the name of accused Prateek Goel 37gm of methamphetamine was recovered. Further, on disclosure of accused Nadeem further parcels were seized and one was in name of Venkata Reddy containing 8.91gm of methamphetamine and parcel in name of Gaurav Matolia was containing 2.42gms of methamphetamine. FSL result is positive for methamphetamine hydrochloride, therefore, on the basis of documents filed alongwith complaint and complaint, undersigned takes cognizance of the offence punishable u/s 22, 23 and 29 NDPS Act.
