CHARGE

I, Bhanumathi B.C., B.A.L, LL.B., I Addl. District and Sessions Judge, Chikkamagaluru, do hereby charge you:

A1 Kumaraswamy S/o Nanjaiah,
Aged about 45 years,

A2 Madhu B.K S/o Kumaraswamy
Aged about 22 years,

A3 Chandrakala W/o Kumaraswamy
Aged about 43 years,
All are residing at Belenahalli village,
Tarikere town,
Chikkamagaluru District.

as follows:

That on 25.10.2024 at about 11.00 a.m, when you accused No.1 to 3 were found engaged in plastering the wall of your house which was situated behind the house of CW.2-Amruthamma at Belenahalli, Tarikere Taluk within the jurisdiction of Tarikere police station, CW.1-Onkamma, sister of CW.2 went there and questioned you as to why you were doing plastering work in their land and damaging the wall of their house and at that time, you accused No.3 with common intention abused CW.1 in filthy language, knowing fully well that such

provocation would cause her to break public peace and thereby you committed an offence punishable under section 352 of Bharatiya Nyaya Sanhita 2023 r/w section 3(5) of said Sanhita and within my cognizance.

2. Secondly, on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 dragged CW.1 by holding her hand and you accused No.2 slapped her and thereby having having voluntarily caused simple hurt to CW.1, you committed an offence punishable under section 115(2) of Bharatiya Nyaya Sanhita, 2023 r/w section 3(5) of said Sanhita and within my cognizance.

3. Thirdly, on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 dragged CW.1 by holding her hand and torn her saree and jacket with an intention to disrobe her and thereby you committed an offence punishable under section 76 of Bharatiya Nyaya Sanhita, 2023 r/w section 3(5) of said Sanhita and within my cognizance.

4. Lastly, on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 to 3 issued threat to the life of CW.1 and thereby you committed an offence of criminal intimidation punishable under section 351(3) of Bharatiya Nyaya Sanhita 2023 r/w section 3(5) of said Sanhita and within my cognizance.

And I hereby direct that you be tried by this court on the above said charges.
