CHARGE

I, Sri.Prakash V., B.A(L).,LL.B., C/c II Addl., District and Sessions Judge, Chikkamagaluru, do hereby charge you:

Shivanappa S/o Hanumanthappa,
Aged about 32 years,
R/at: Donamaradi camp,
Maski Taluk, Raichuru,
Native: Malladagudda Maski Taluk,
Raichuru.

as follows:

That CW-1 Smt.Palakshamma's husband was a drunkard, he used to had frequent quarrel with her by consuming alcohol, in order to forget the same, she used to watch Facebook, during that time, you accused became acquainted with CW.1 through facebook about 4 years back, thereafter you accused introduced yourself working as Police Constable at Manvi, Raichuru, CW.1 used to tell her personal matters to you, in the guise of consoling her, you became closer to her, on 16.02.2019, you came to the house of CW-1 when she was alone, situated at Basaveshwara Extension, Ajjampura Town within the jurisdiction of Ajjampura Police Station, you

accused even after knowing that CW.1 was married, by taking advantage of the lack of compatibility between CW-1 and her husband, on the premise of marrying her, you forcibly committed sexual intercourse with her and you accused possessed personal video and photographs of CW.1 and by threatening to show the same to her husband and brother, you had forcible sexual intercourse with her about four years back by blackmailing her at Raghadeepa lodge, Mantralaya, similarly, you had forcible sexual intercourse with CW.1 on several occasions i.e., on 08.12.2019 during training period at Bangalore, at Room No.208 of Ruchitha Comfort lodge, R.K.Puram, Bangalore, during the period from 2020 to 2024 March 30.03.2024, when you are working at Manvi, by taking rooms at Vijayashri Tourist Home lodge situated near Manvi Police Station, by taking advantage of you being police constable had not marking any documents in their room ledger, you had forcible sexual intercourse with CW.1 continuously for 4 years and thereby you accused committed an offence of rape repeatedly against same woman punishable under Section 376(2)(n) of Indian Penal Code and within my cognizance.

Secondly, you accused had financial transaction with CW.1, when you accused refused to repay the amount, on 16.08.2023 at Manvi, Raichuru you assaulted CW.1 with hands and voluntarily caused simple hurt to her and on 14.01.2024 you had taken CW.1 near

Basaveshwara Kalyana Mantapa, Ajjampura, threatened her not to give complaint against you, pulled her hair and voluntarily caused simple hurt to CW.1 by assaulting her and thereby you accused committed an offence punishable under section 323 of Indian Penal Code and within my cognizance.

Thirdly, on 11.09.2023 you accused called CW.1 to Manvi, picked up quarrel with her with regard to financial matter, you assaulted CW.1 with slipper on her person and dishonored her and thereby you the accused committed an offence punishable under section 355 of Indian Penal Code and within my cognizance.

Fourthly, on 14.01.2024, you accused came to Ajjampura, called CW.1 near Basaveshwara Kalyana Mantapa, issued threats to the life of CW.1, if she gives complaint against you in the police Station and thereby you the accused committed an offence punishable under Section 506 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
