C H A R G E

I, Bhanumathi B.C., B.A.L, LL.B., I Addl. Sessions and Special Judge, Chikkamagaluru, do hereby charge you:

Preetham @ Preetham Mendonsa, S/o
Selva, Aged about 38 years, Driver, R/o
No.183 Ashraya Badavane,
Kalyananagara, Chikkamagaluru.

as follows:

That on 14.10.2024 at about 10.30 P.M, you the accused went near the house of CW.1–Smt.Swathi V situated at Kalyana Nagara, Chikkamagaluru within the jurisdiction of Women Police Station, Chikkamagaluru in a TATA ACE vehicle bearing registration No.KA-09/AA-1855 and therein, you issued threat to the life of CW.1 by asking her about the whereabouts of her sister and later on 15.10.2024 at 7.00 A.M, you the accused again went to the house of CW-1 and issued threat to her life by asking about her sister and thereby you committed an offence of criminal intimidation punishable under section 351(3) of Bharatiya Nyaya Sanhita 2023 and within my cognizance.

2. Secondly, on 15.10.2024 at about 7.00 A.M, you accused trespassed into aforesaid house of CW.1 with an

intention to commit crime and thereby you the accused committed an offence punishable under section 329(4) of Bharatiya Nyaya Sanhita, 2023 and within my cognizance.

3. Thirdly, on the aforesaid date, time and place, you accused held the neck of CW.1 and burnt the upper part of left side of her chest with a cigarette and thereby having voluntarily caused simple hurt to CW.1, you accused committed an offence punishable under section 115(2) of Bharatiya Nyaya Sanhita, 2023 and within my cognizance.

4. Fourthly, on the aforesaid date, time and place, you burnt the upper part of left side of her chest with a cigarette with an intention or knowledge that your act is likely to outrage her modesty you committed an offence punishable under Section 74 of Bharatiya Nyaya Sanhita, 2023 and within my cognizance.

5. Fifthly, on the aforesaid date, time and place, you accused abused CW.1 in filthy language, knowing fully well that such provocation would cause her to break the public peace and thereby you accused committed an offence punishable under section 352 of Bharatiya Nyaya Sanhita, 2023 and within my cognizance.

6. Sixthly, on 15.10.2024 at the aforesaid time and place, you accused not being the member of any Scheduled Caste or Scheduled Tribe, intentionally insulted CW.1, a member of a Scheduled Caste with intent to humiliate her within public view and thereby you accused committed the offence punishable under section 3(1)(r) of the SC & ST (Prevention of Atrocities) Act, 2015 and within my cognizance.

7. Seventhly, on the aforesaid date, time and place, you accused not being the member of any Scheduled Caste or Scheduled Tribe, abused CW.1, a member of a Scheduled caste by touching the name of her caste within public view

and thereby you accused committed the offence punishable under section 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, 2015 and within my cognizance.

8. Eighthly, on the aforesaid date, time and place, you accused not being the member of any Scheduled Caste or Scheduled Tribe, burnt the upper part of left side of chest of CW.1 with a cigarette, knowing that she belongs to a Scheduled Caste and thereby you accused committed an offence punishable under Section 3(1)(w)(ii) of the SC & ST (Prevention of Atrocities) Act, 2015 and within my cognizance.

9. Lastly on the aforesaid date, time and place, you accused not being the member of any Scheduled Caste or Scheduled Tribe, committed the offences under sections 115(2), 74 and 351(3) BNS (corresponding to sections 323, 354 and 506 of IPC) against CW.1 knowing that she is a member of a Scheduled Caste and thereby you accused committed an offence punishable under section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

And I hereby direct that you be tried by this court on the above said charges.
