CHARGE

I, Bhanumathi B.C., B.A.L, LL.B., I Addl. District and Sessions Judge, Chikkamagaluru, do hereby charge you:

1. Sunil, S/o Nataraj, Aged about 30 years,
2. Jayanthi, W/o Sunil, Aged about 24 years,
3. Nirmala, W/o Nataraj, Aged about 55 years,
A1 to A3 are residing at #377, 3rd floor, 4th cross, Bellanduru, Bengaluru City. Permanently residing behind Kaveri sawmill, Kempanahalli, Chikkamagaluru.
4. Shruthi, W/o Madhu, Aged about 32 years, R/at Aravindanagara last cross, Chikkamagaluru town.

as follows:

That a new house was being constructed by you the accused No.3 behind Kaveri sawmill, Kempanahalli village, Chikkamagaluru town and that on 26.01.2024 at about 10 a.m, when CW.1-Shanthi, CW.4-Sharath and

CW.5-Narayanamurthy questioned you in the said regard, you accused No.3 with common intention abused them in filthy language and gave provocation, knowing fully well that such provocation would cause them to break the public peace and thereby you accused committed an offence punishable under section 504 of Indian Penal Code r/w Section 34 of the said Code and within my cognizance.

2. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 and 2 dragged CW.1 by holding her saree, you accused No.1 kicked her, you accused No.2 and 4 pulled her by holding her head and you accused No.1 to 4 threw mud towards CW.4 and thereby having voluntarily caused simple hurt to CW.1 and 4, you accused committed an offence punishable under section 323 of Indian Penal Code r/w Section 34 of the said Code and within my cognizance.

3. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.2 and 4 assaulted CW.1 with a cement brick on her head and thereby having voluntarily caused simple hurt to CW.1, you accused committed an offence punishable under section 324 of Indian Penal Code r/w Section 34 of the said Code and within my cognizance.

4. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.3 issued threat to the lives of CW.1, CW.4 and CW.5 and thereby you accused committed an offence of criminal intimidation punishable under section 506 of Indian Penal Code r/w Section 34 of the said Code and within my cognizance.

5. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1,

2 and 4 used criminal force on CW.1 by assaulting her with hands and brick and by dragging her by holding her saree and head, with an intent to outrage her modesty and thereby you accused committed an offence punishable under section 354 of Indian Penal Code r/w Section 34 of the said Code and within my cognizance.

And I hereby direct that you be tried by this Court on the said charges.
