C H A R G E

I, Manjunath Sangreshi, B.A., LL.B., (HONS), II Addl., District
and Sessions Judge, Chikkamagaluru, do hereby charge you,

Abdul Razaq S/o Syed Sadiq,
Aged about 23 years, Coolie,
R/o Ajjampura,
Native: Banavara, Arasikere Taluk.

as follows:

That in Ajjampura village, within the jurisdiction of Ajjampura
Police Station, you accused No.1 married the deceased
Smt.Thabaraq Banu on 18.07.2018 and after the marriage you
accused and deceased Smt.Thabaraq Banu were residing along with
CW.1, thereafter, you accused demanded cash of Rs.50,000/- for the
purpose of purchase Autorickshaw, when CW.1 refused the same,
you accused subjected your wife Smt.Thabaraq Banu to physical and
mental cruelty in connection with your demand for dowry. Further
the deceased and you accused residing separately in the rented house
of CW.17 and on 16.09.2019 during night at about 11.30 p.m., you
accused picked up quarrel with the deceased Smt.Thabaraq Banu,
demanded money, forcibly slapped on her cheek with your hands,
murdered her and thereby committed the offence punishable under
section 302 of IPC and within cognizance of this Court.

That you accused demanded Rs.50,000/- cash as dowry from the deceased Smt.Thabaraq Banu and her parents and thereby committed the offence punishable under section 4 of Dowry prohibition Act with the cognizance of this Court.

That on the above said date, time and place you accused with an intention to murder your wife, picked up quarrel with her and assaulted on her cheek forcibly with your hands and murdered her, as her death occurred within seven years of her marriage with you and thereby you have committed the offence dowry death punishable under section 304-B of IPC and within cognizance of this Court.

That on the above said date, time and place, in order to screen the evidence of offence from legal punishment, you accused after murdering your wife, made the dead body as sleeping on the bed, and told that the deceased fallen on the bed due to giddiness because of low B.P. and thereby you have committed the offence of causing disappearance of evidence punishable under section 201 and within cognizance of this Court.

And I hereby direct that you be tried by this Court on the above said charges.
